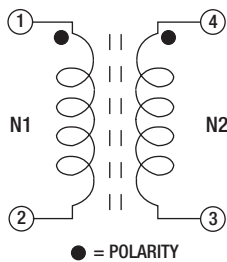

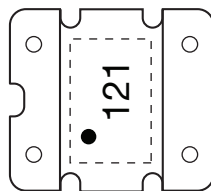

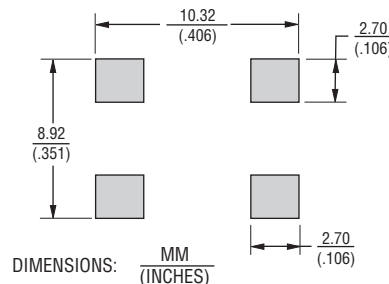

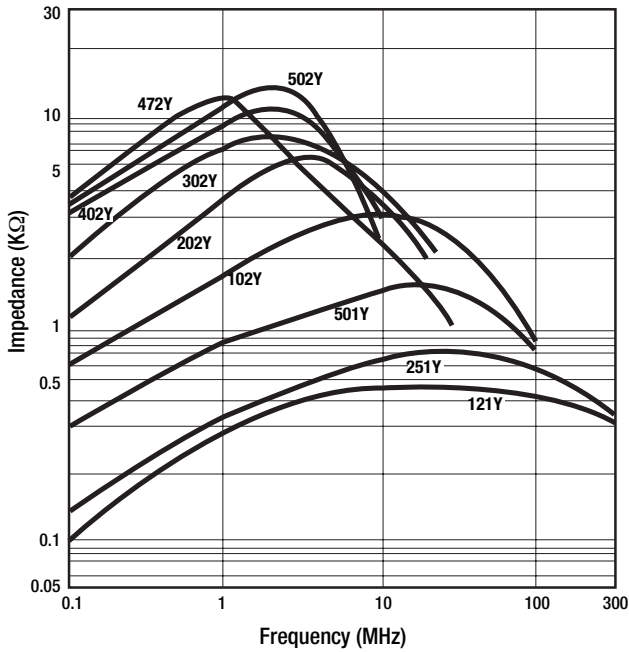

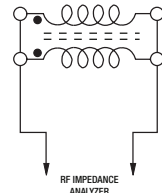

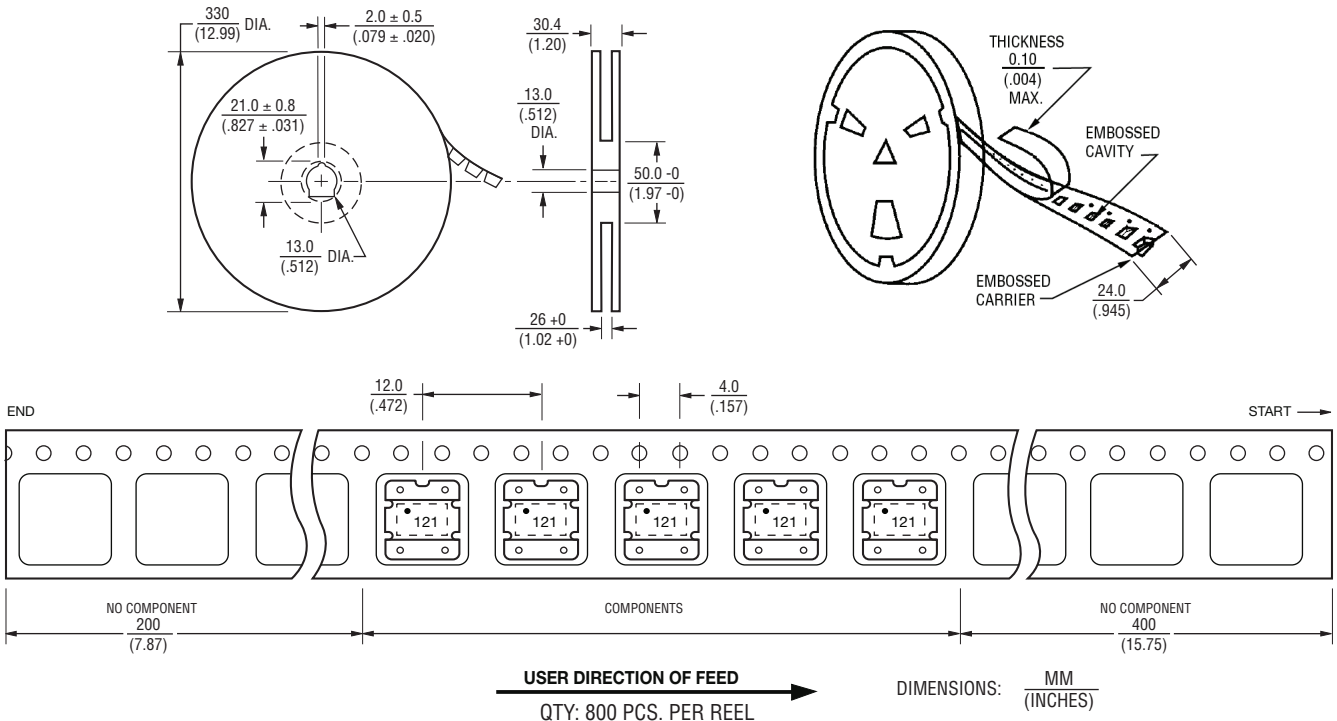
Impedance Graph
