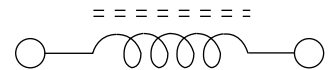

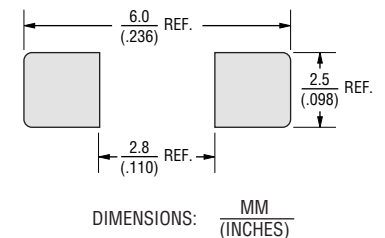

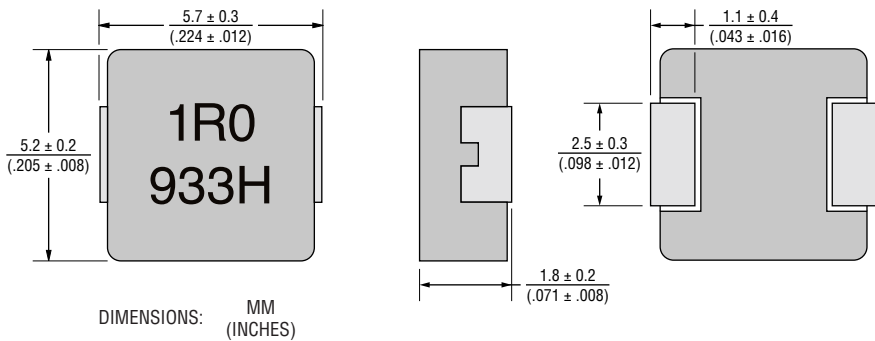
Schematic



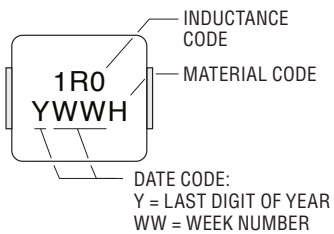
Recommended Layout
