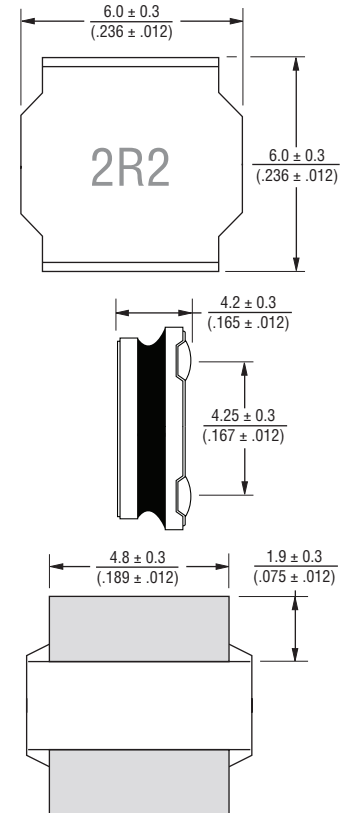

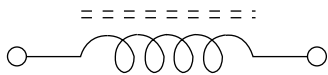

### Electrical Schematic

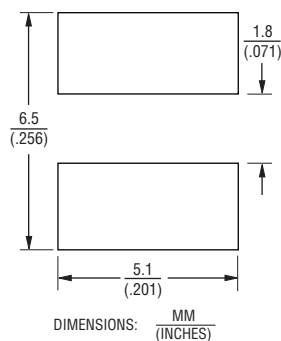

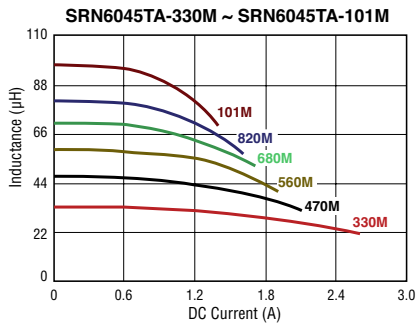
