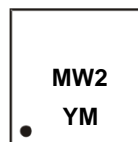
Device Schematic

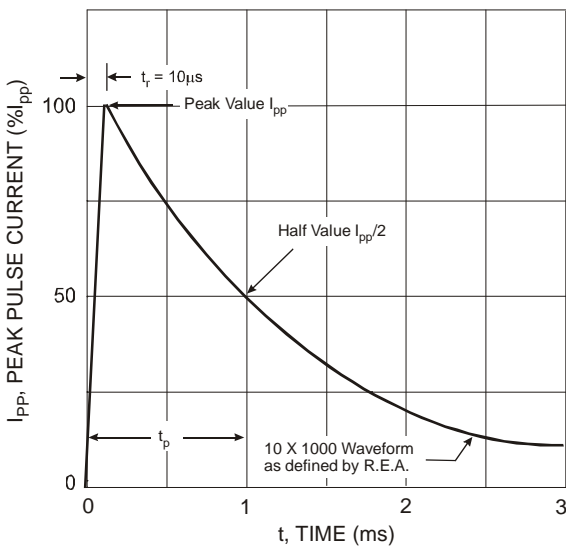


Figure 1 Pulse Waveform

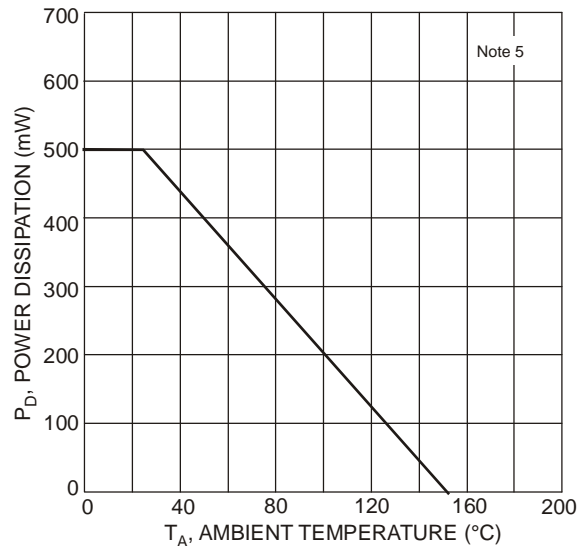


Figure 2 Power Derating Curve

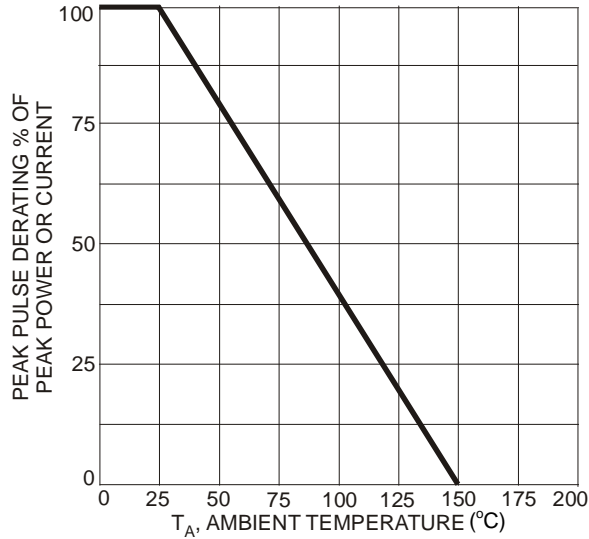


Figure 3 Power Dissipation vs. Ambient Temperature

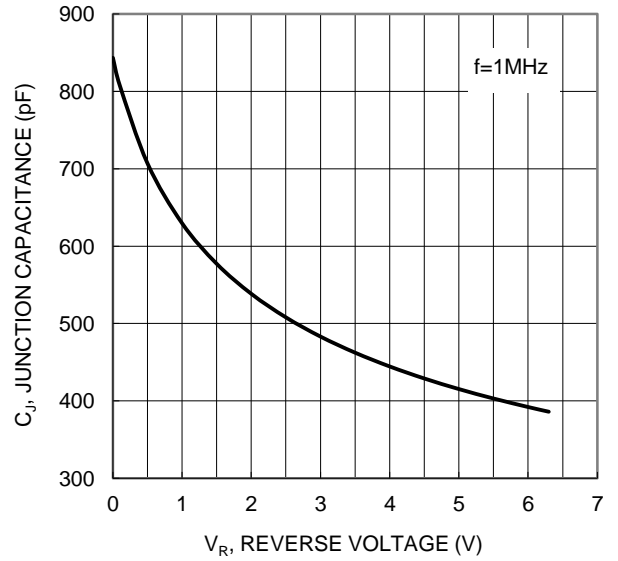
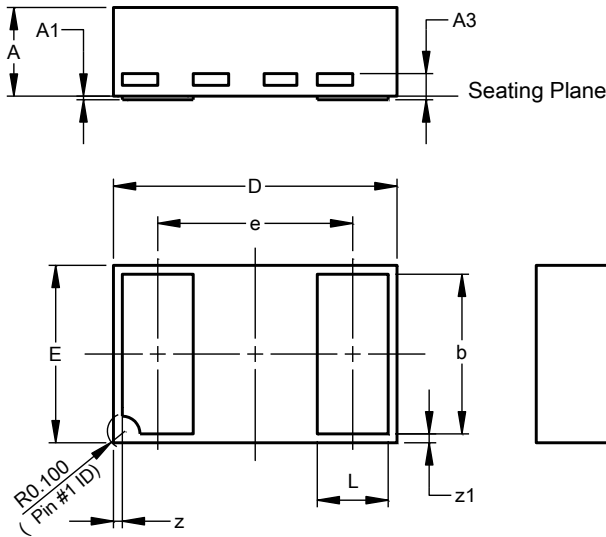


Figure 4 Typical Junction Capacitance

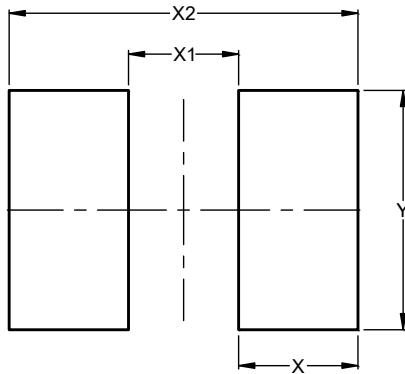
