

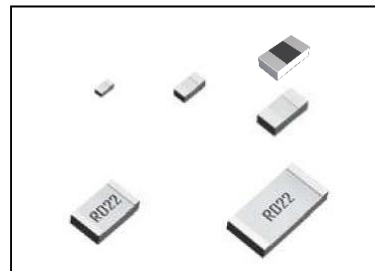

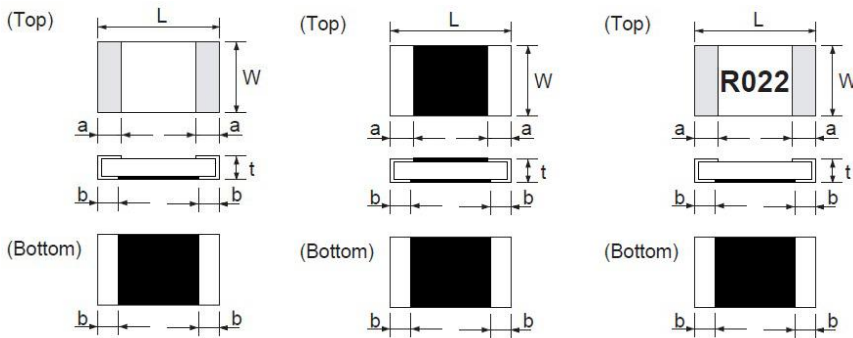

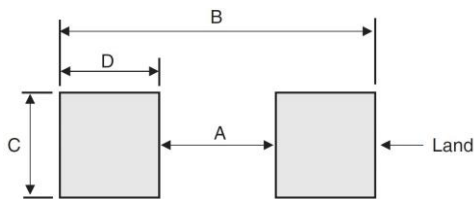

●Land pattern example



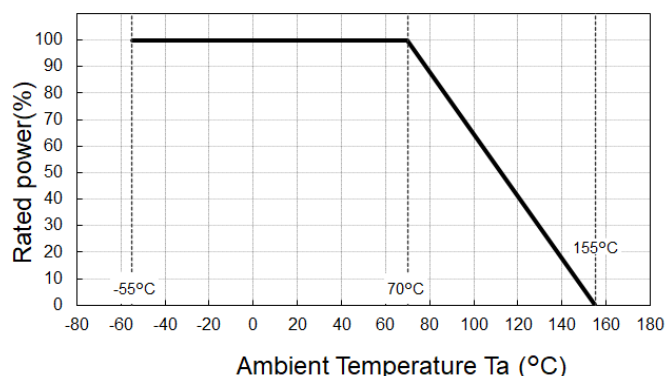


●Derating curve

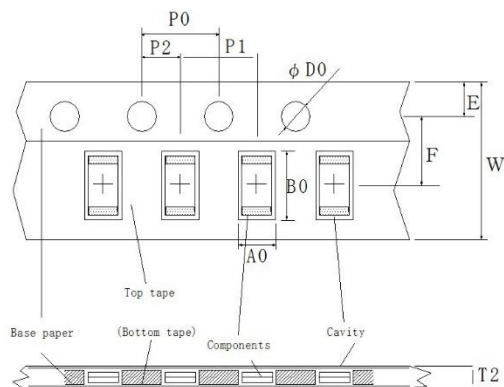

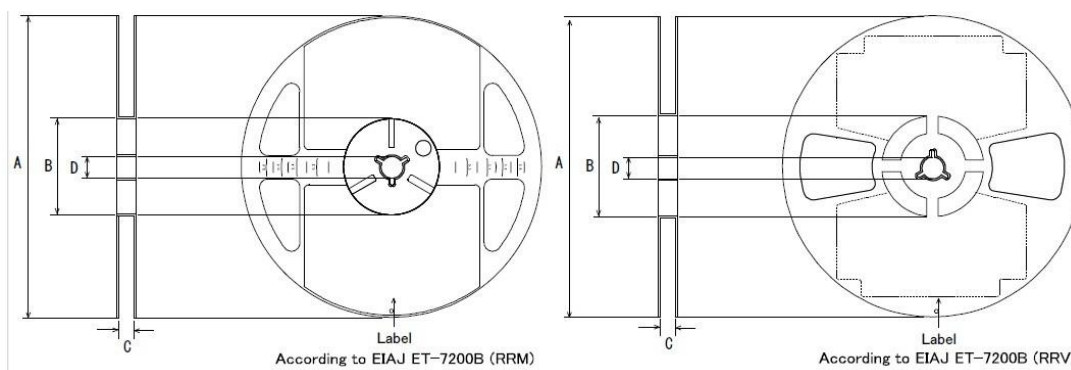
