Typical Impedance Characteristics:

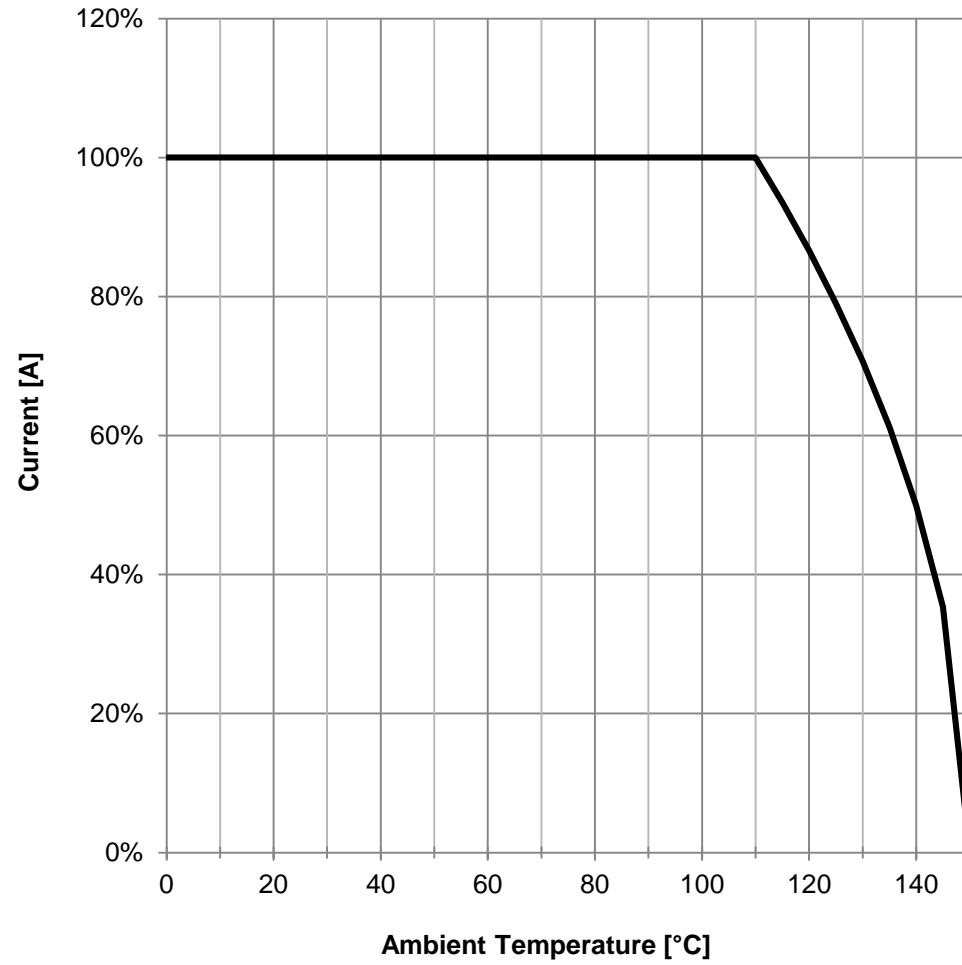


Typical Inductance vs. Current Characteristics:

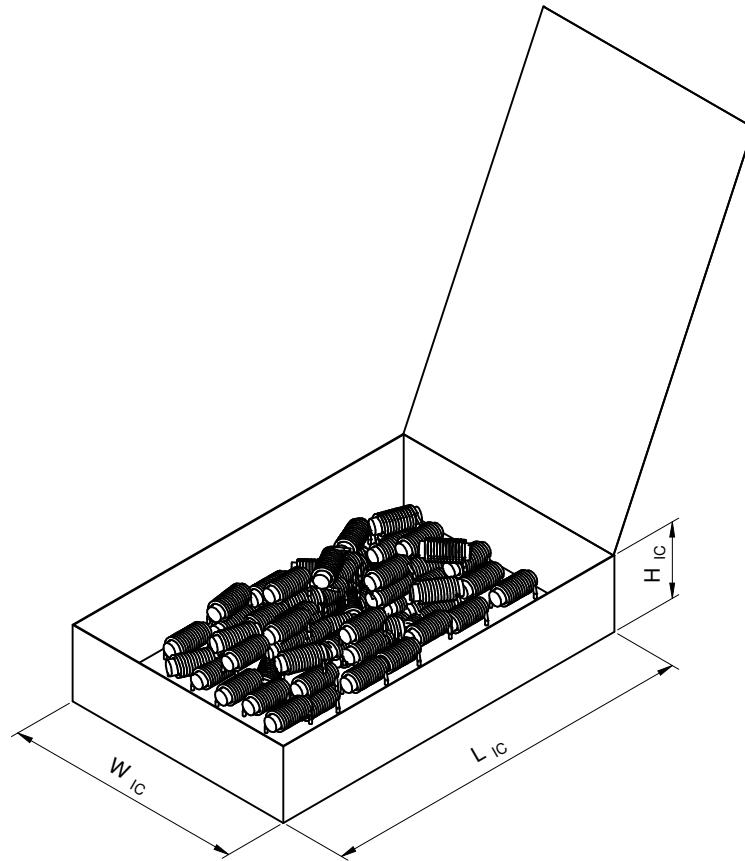
Derating Curve:



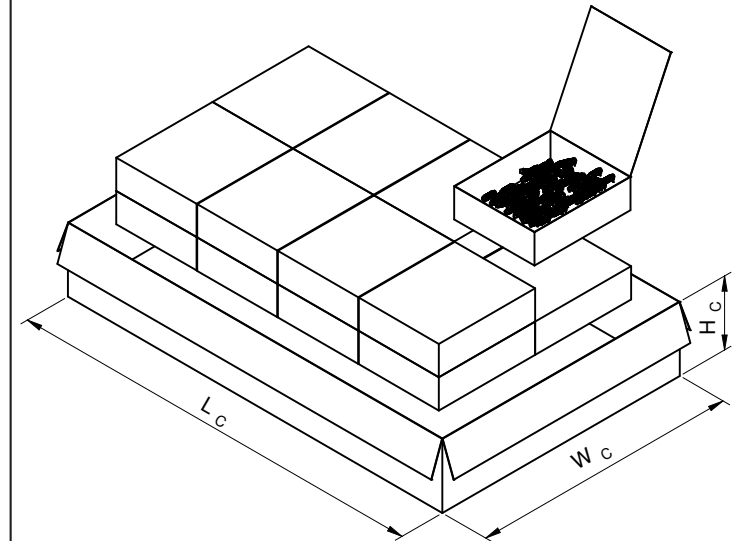





Packaging:


