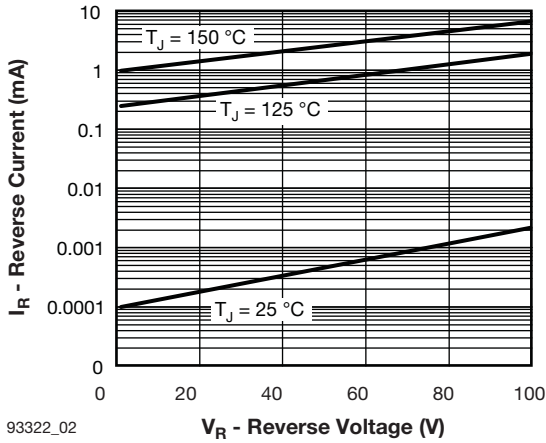

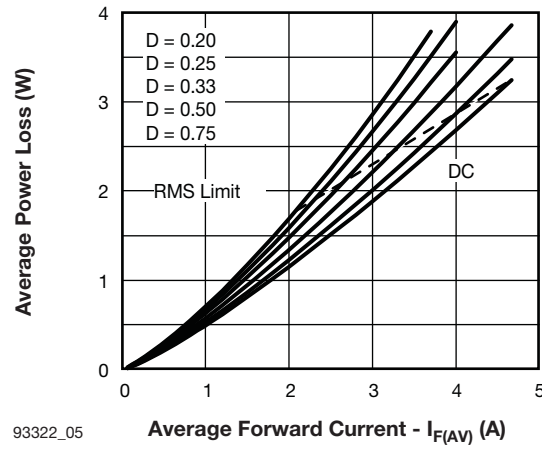
93322_01 **V_{FM} - Forward Voltage Drop (V)**
Fig. 1 - Maximum Forward Voltage Drop Characteristics



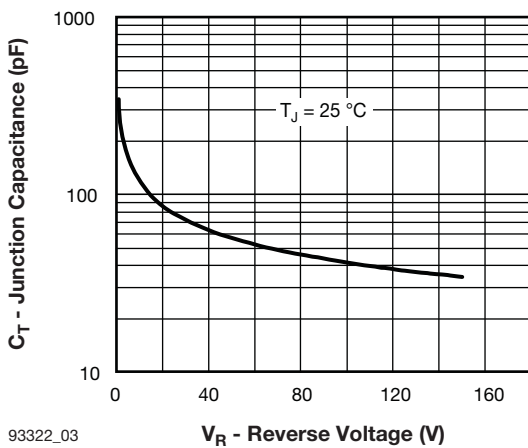
93322_04 **I_{F(AV)} - Average Forward Current (A)**
Fig. 4 - Maximum Allowable Lead Temperature vs. Average Forward Current



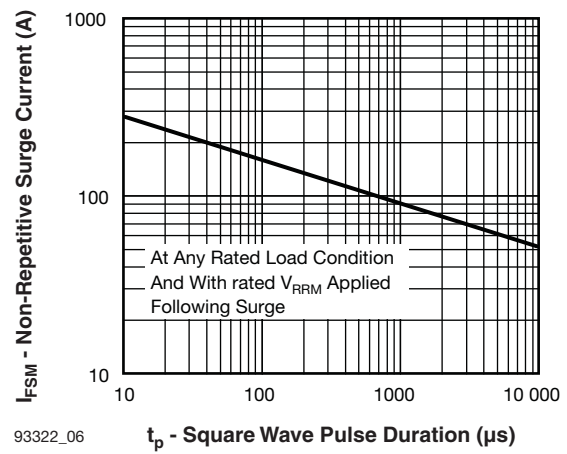
93322_02 **V_R - Reverse Voltage (V)**

Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage



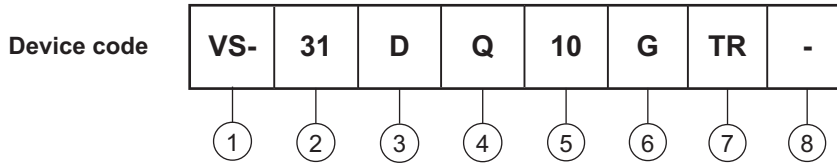
93322_06 **t_p - Square Wave Pulse Duration (μs)**

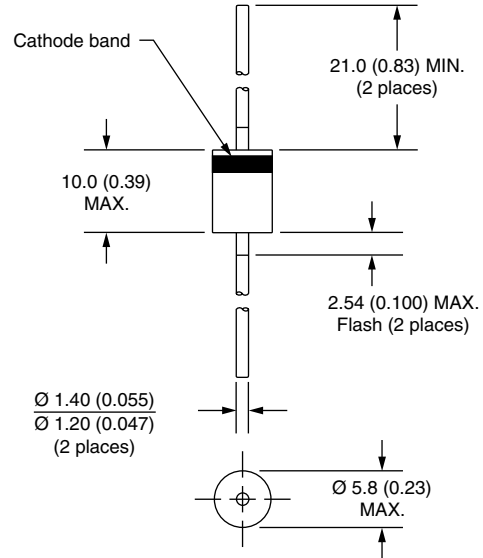
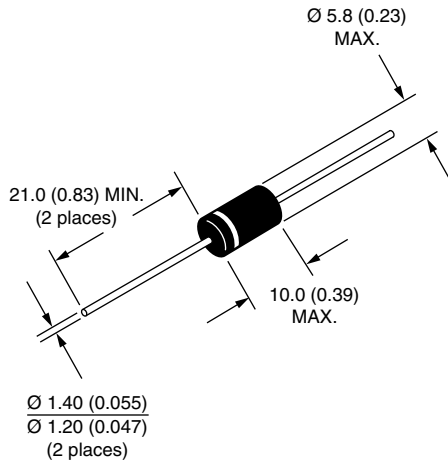
