Typical Attenuation:



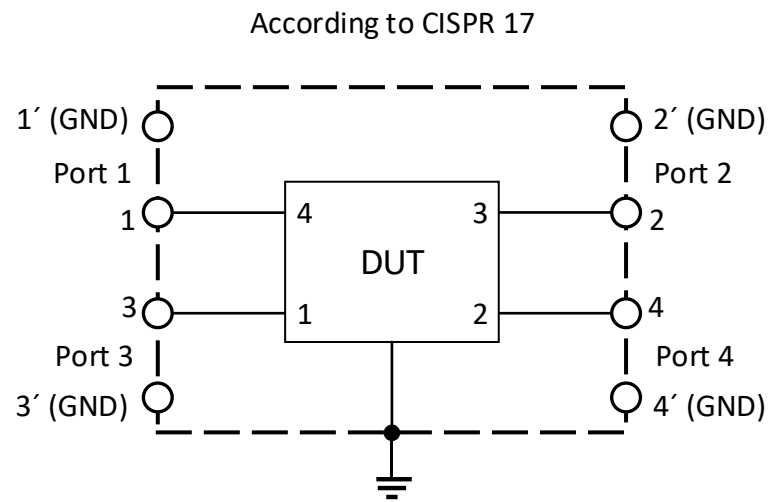

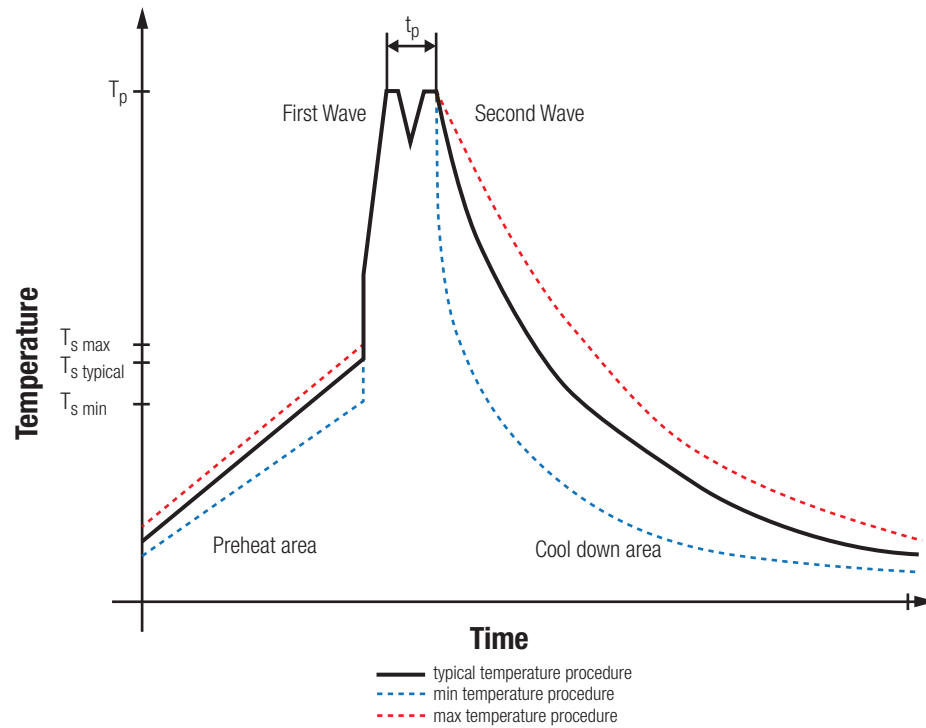



Storage Conditions:


