## CATV Tuning

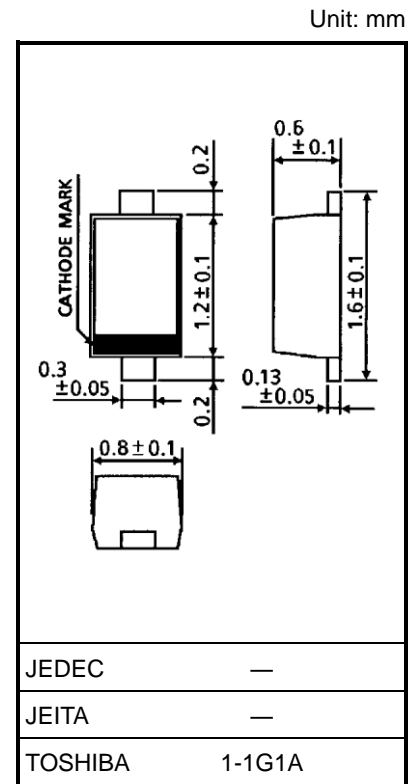
- High capacitance ratio:  $C_{2V}/C_{25V} = 12.5$  (typ.)
- Low series resistance:  $r_s = 0.6 \Omega$  (typ.)
- Excellent C-V characteristics, and small tracking error.
- Useful for small size tuner.
