Typical Impedance Characteristics:



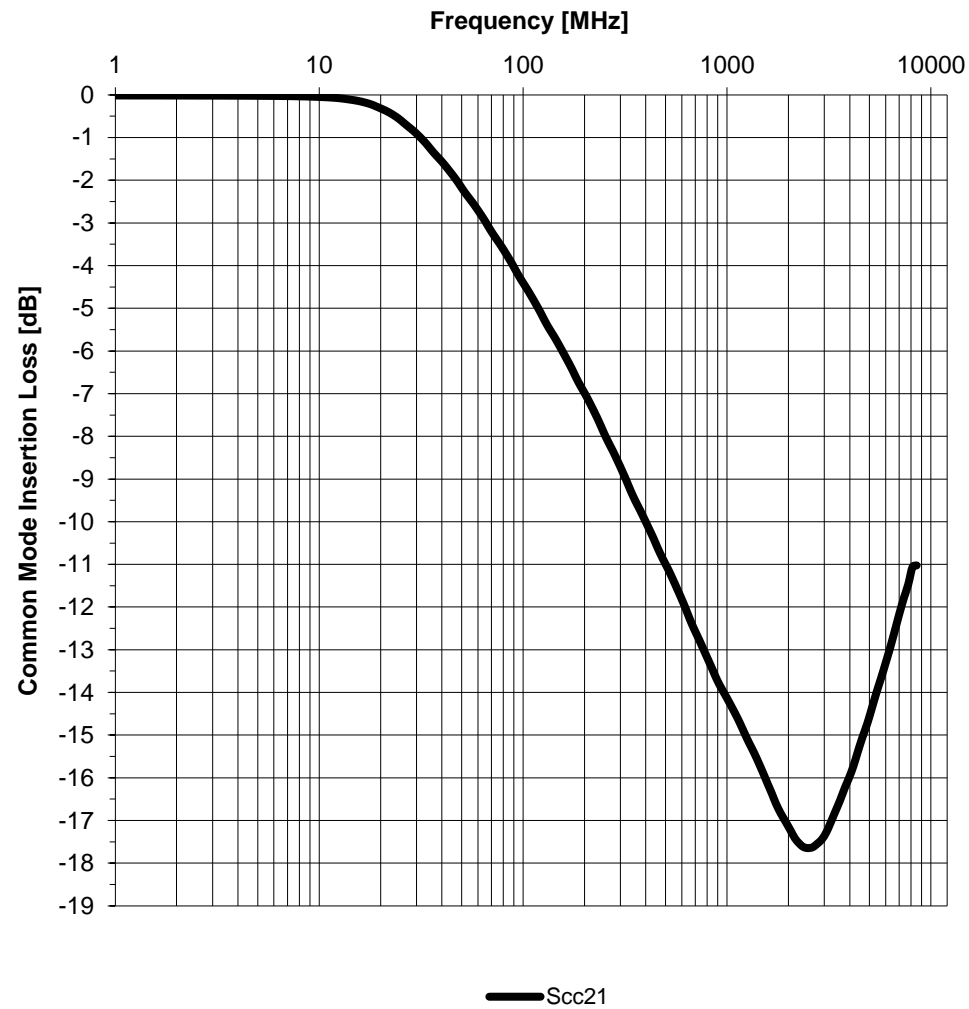
Typical Differential Mode Insertion Loss Characteristics:



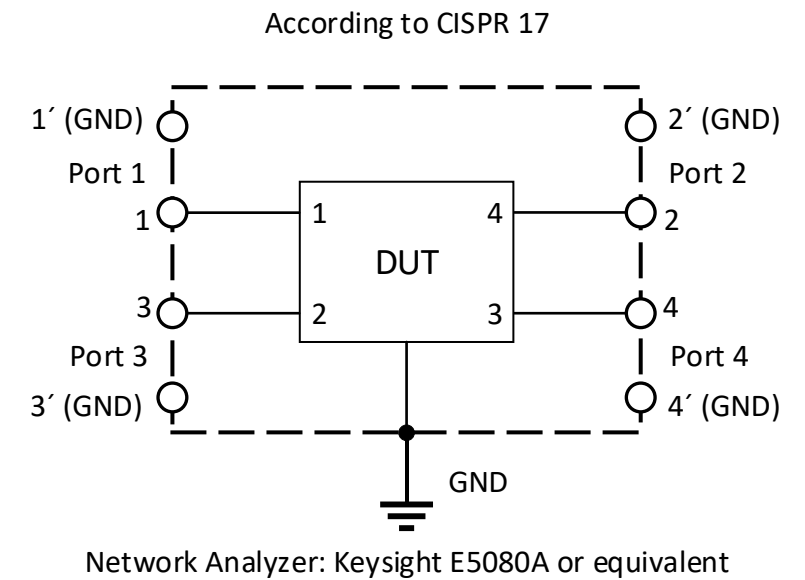

Typical Common Mode Insertion Loss Characteristics:



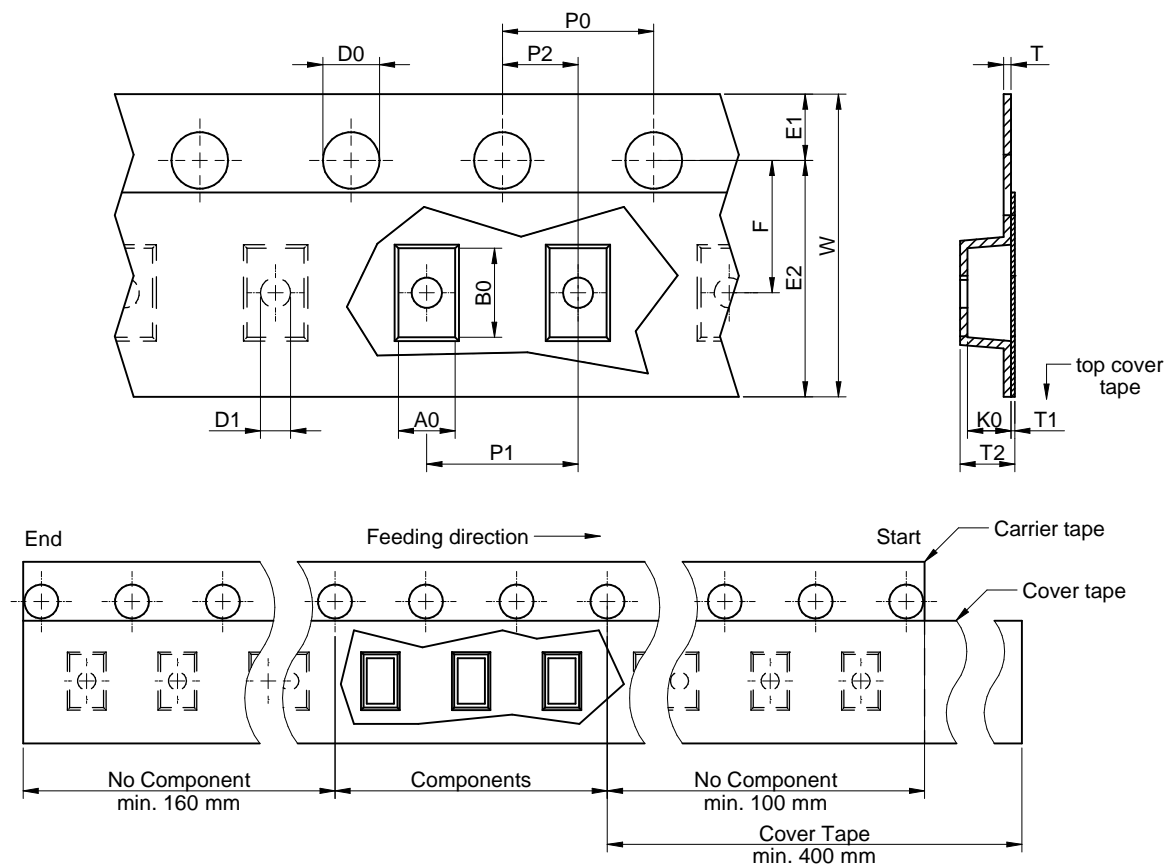

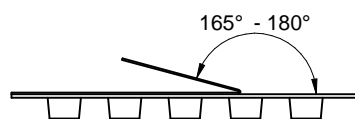

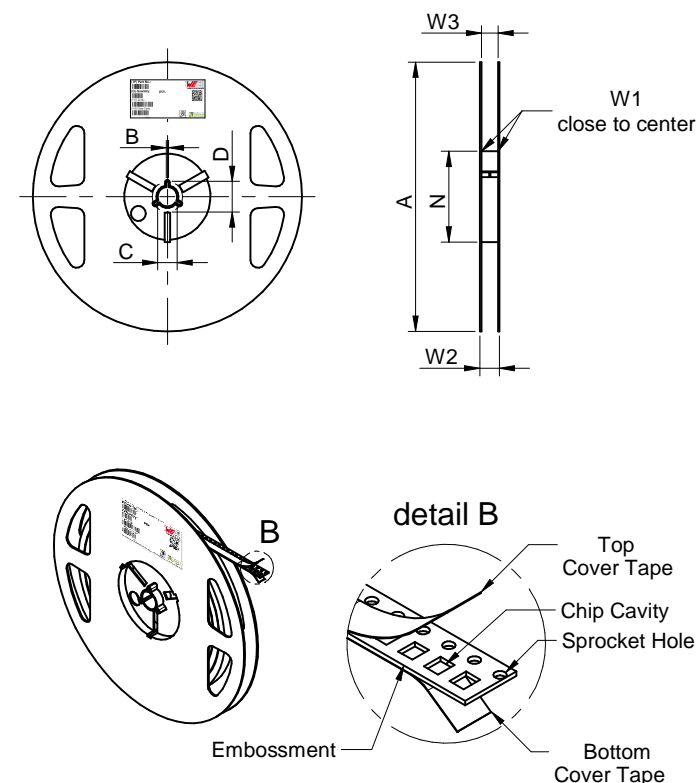

Soldering:




