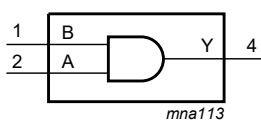


Fig. 1. Logic symbol

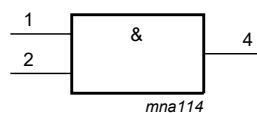


Fig. 2. IEC logic symbol

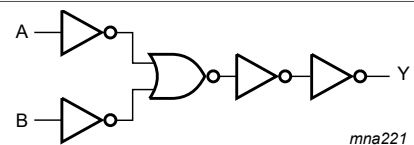


Fig. 3. Logic diagram

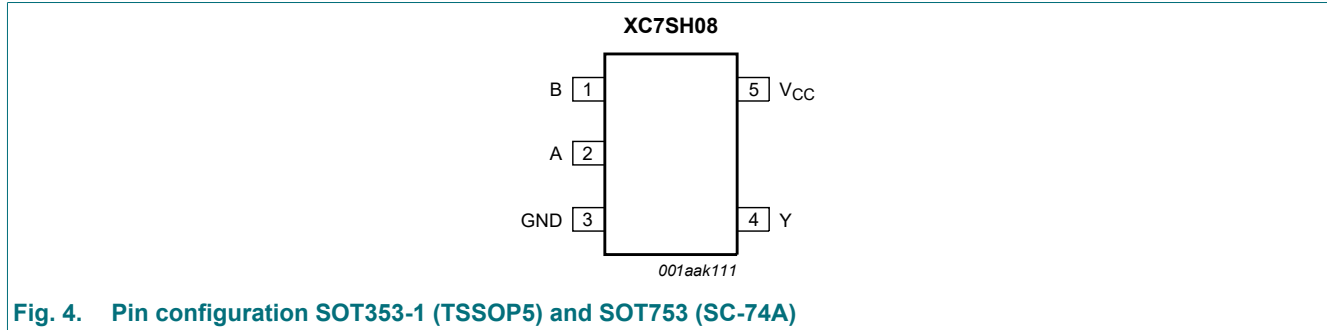


Fig. 4. Pin configuration SOT353-1 (TSSOP5) and SOT753 (SC-74A)

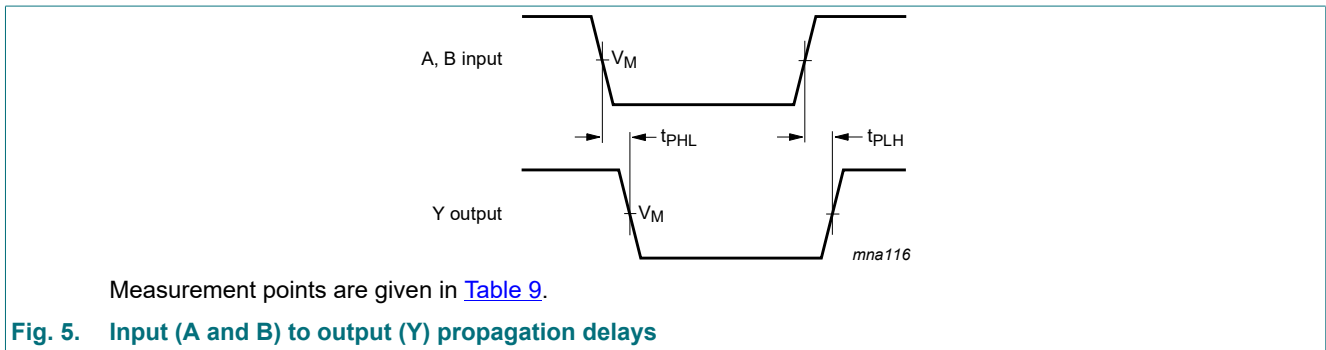
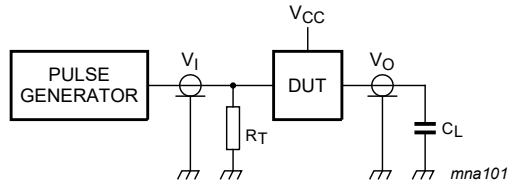

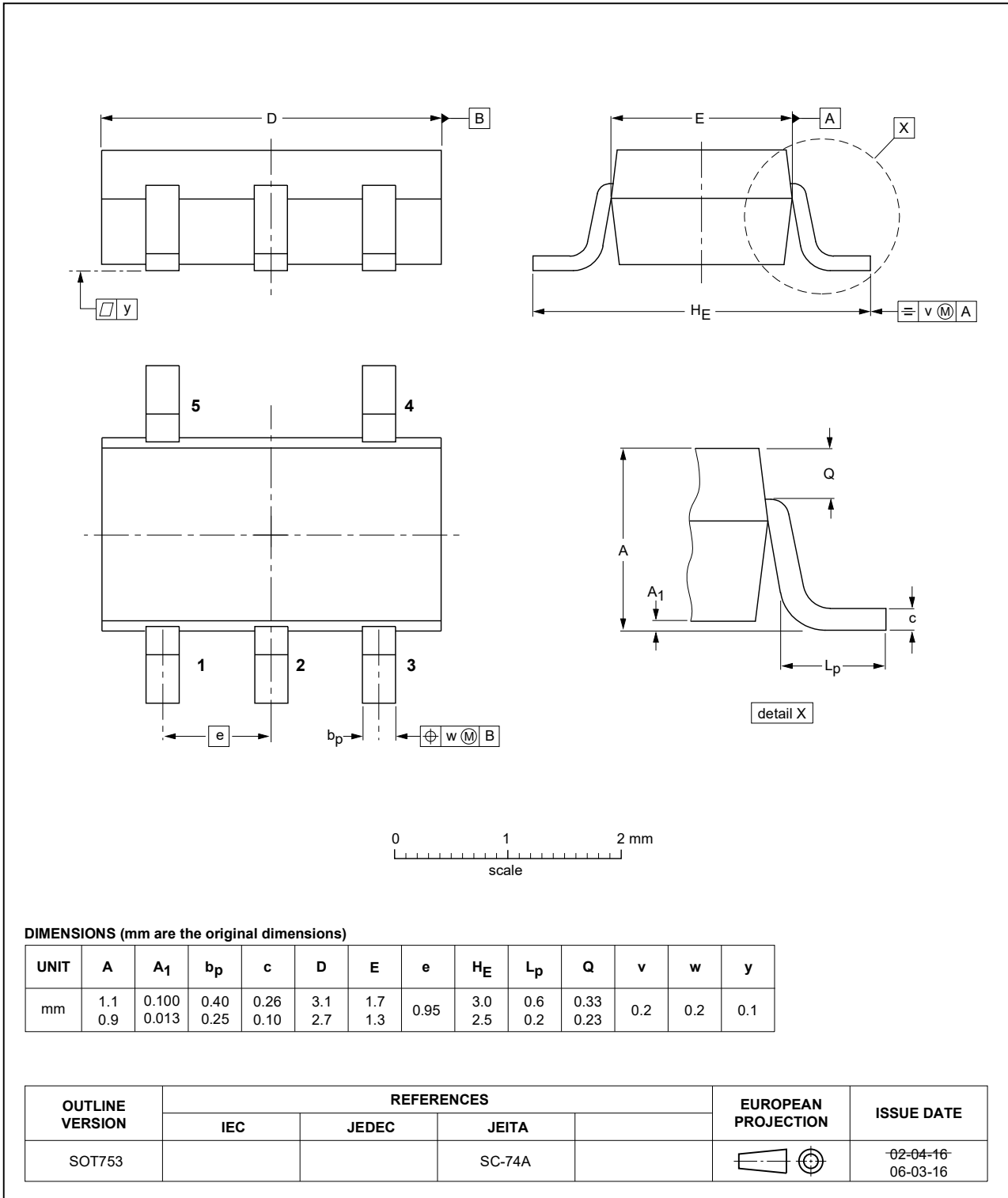


Fig. 8. Package outline SOT753 (SC-74A)
