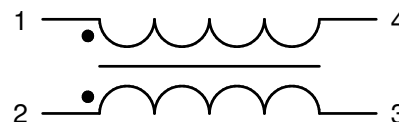

Typical Attenuation:



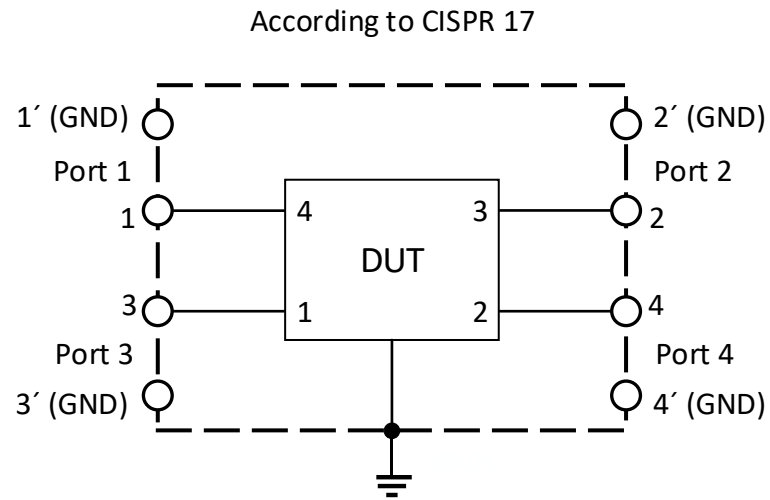

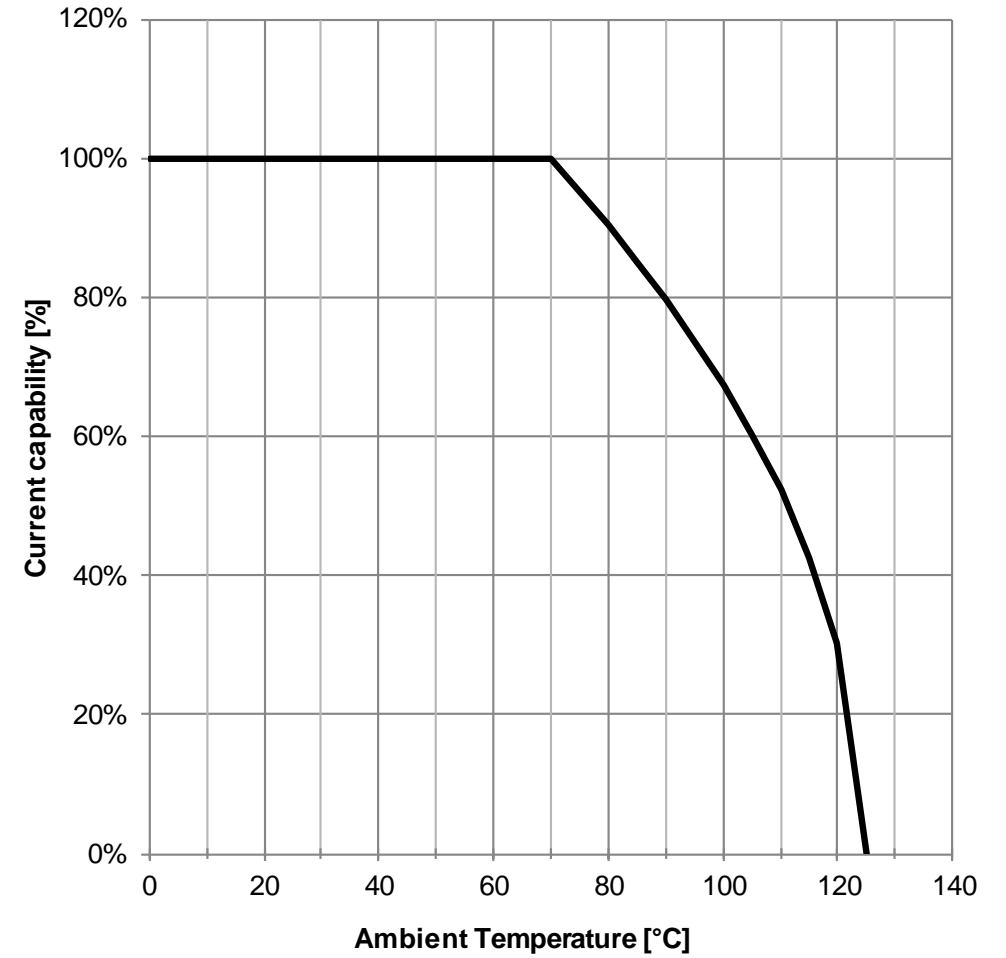

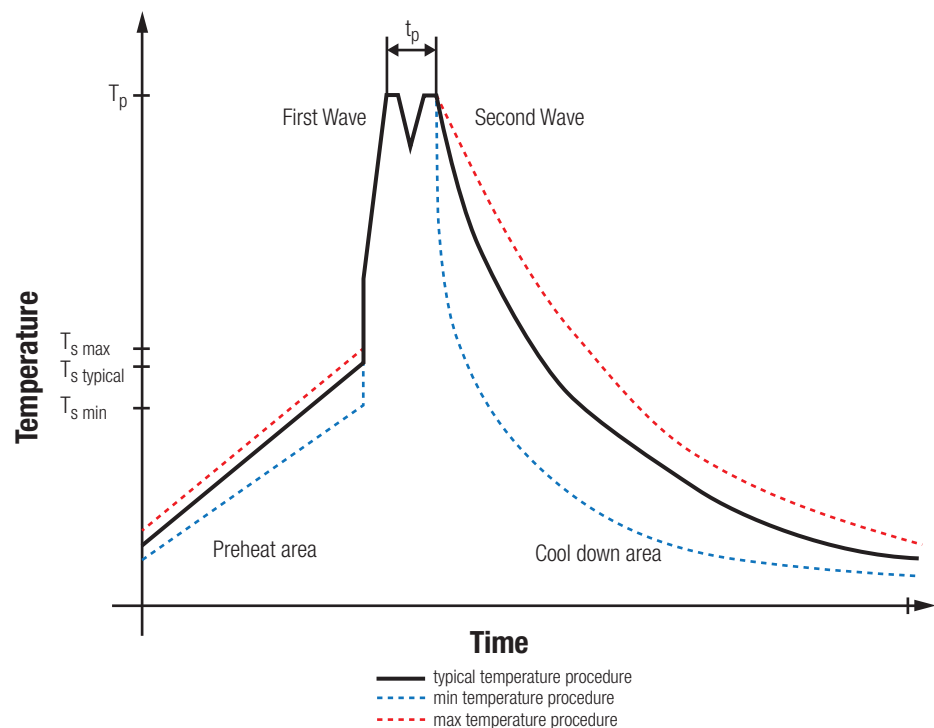
Derating Curve:





Storage Conditions:


