**Typical Impedance vs. Frequency:**



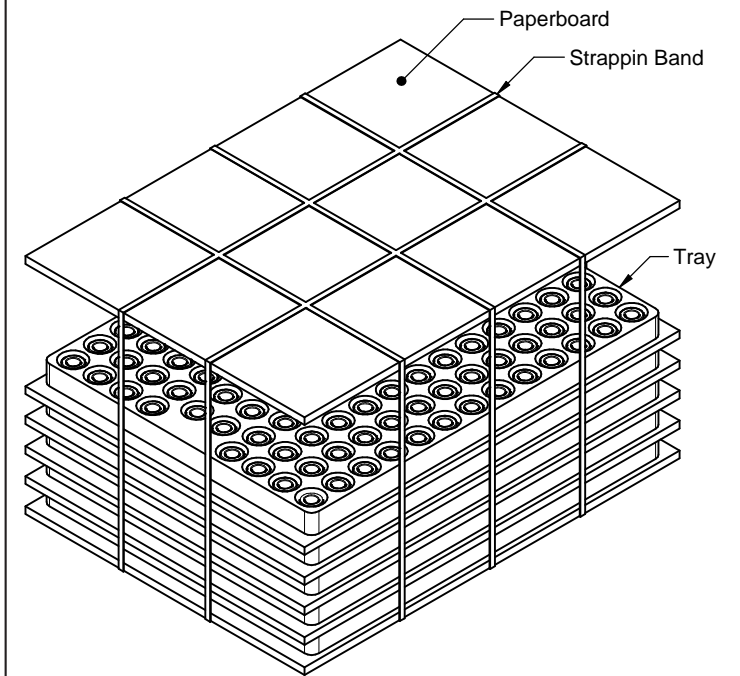

- Cleaning and Washing:



#### Packaging:


