Typical Impedance vs. Frequency:



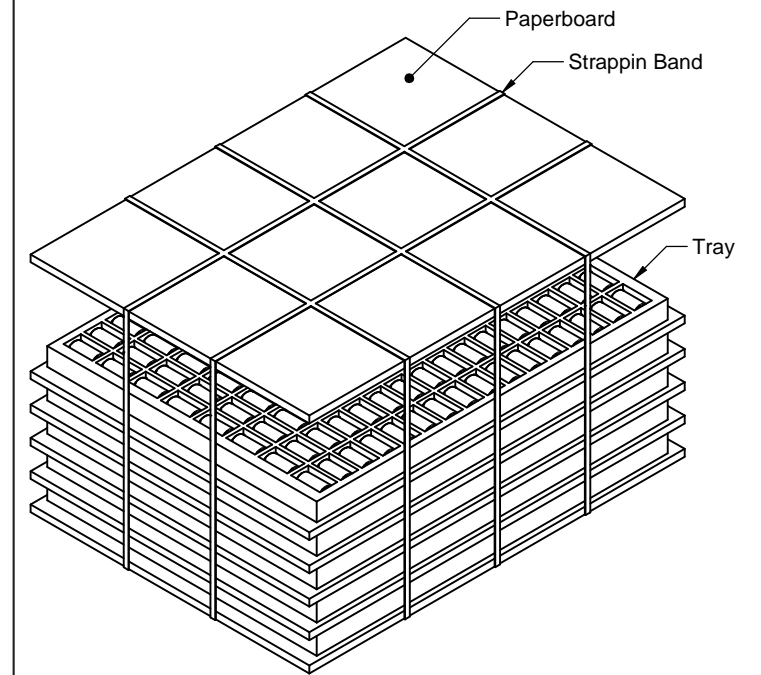

- Cleaning and Washing:



Packaging:


