## 1. General description

---

High performance voltage regulator diodes in a small SOT23 (TO-236AB), Surface-Mounted Device (SMD) plastic package.

## 2. Features and benefits

---

- Very low dynamic impedance at low currents: approximately 5 % of conventional series
- Hard breakdown knee
- Low noise: approximately 10 % of conventional series
- Total power dissipation: max. 250 mW
- Small tolerances of  $V_Z$
- Working voltage range: nominal 5.00 to 6.80 V
- Non-repetitive peak reverse power dissipation: maximal 30 W at 150 °C
- Qualified according to AEC-Q101 and recommended for use in automotive applications




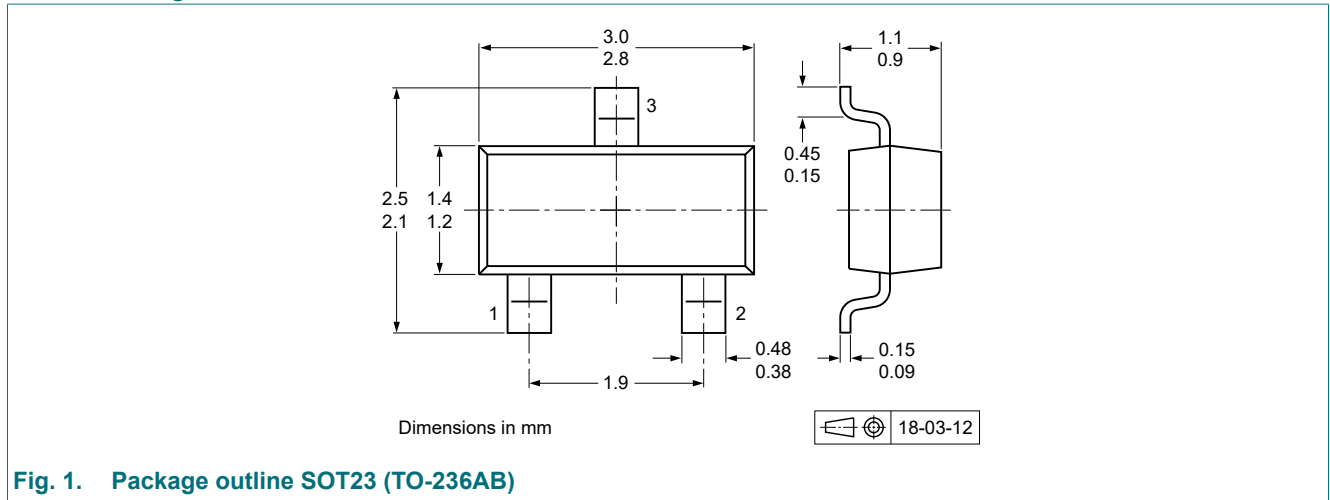


Fig. 1. Package outline SOT23 (TO-236AB)

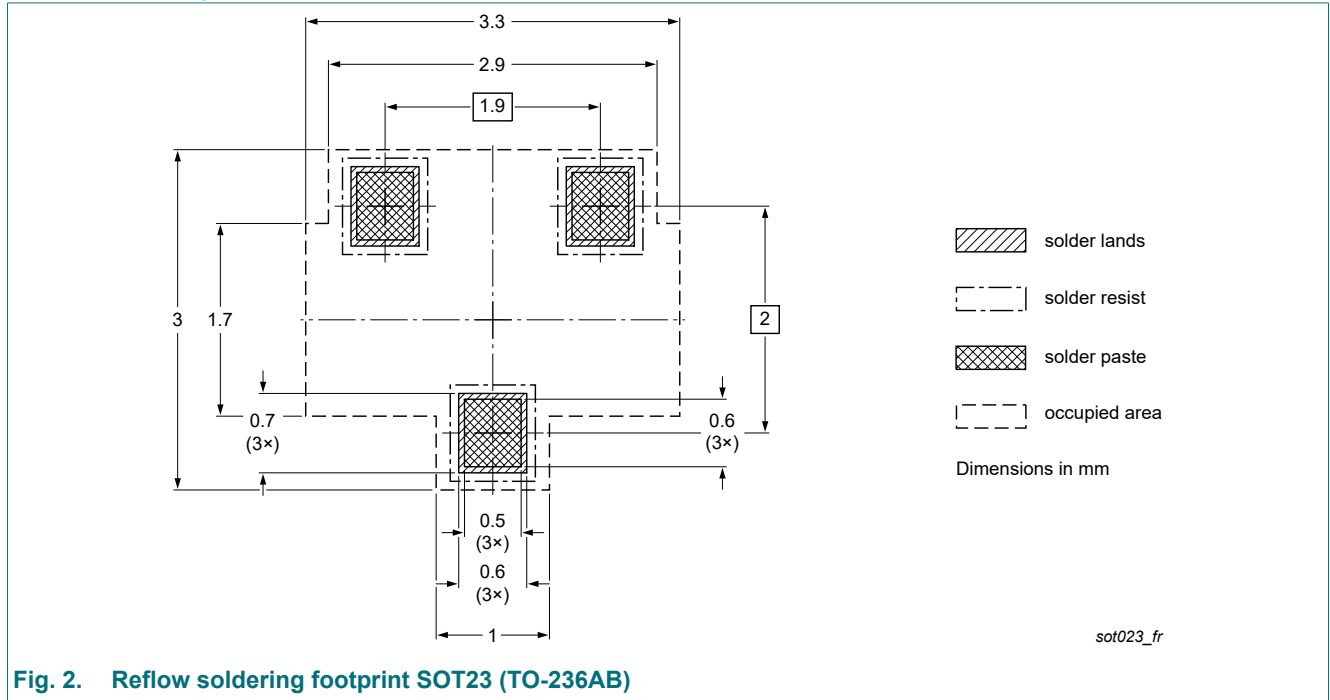


Fig. 2. Reflow soldering footprint SOT23 (TO-236AB)

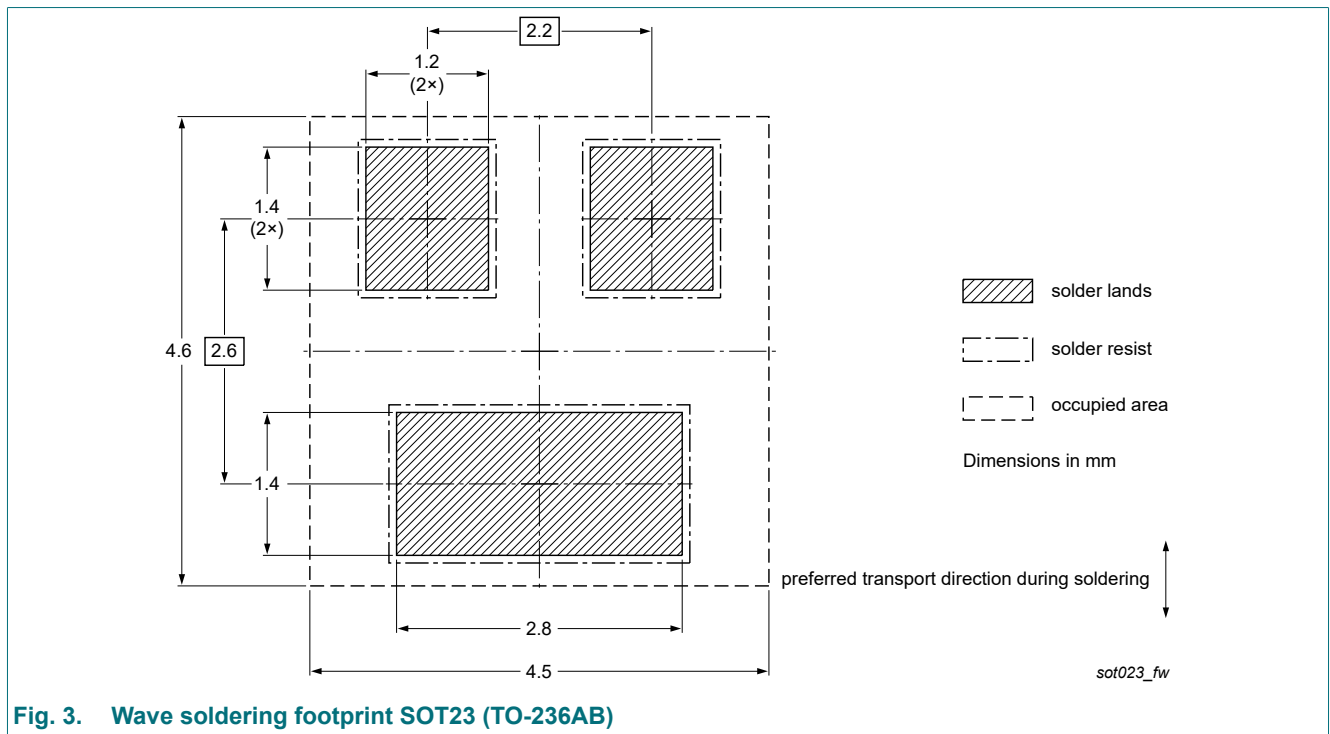


Fig. 3. Wave soldering footprint SOT23 (TO-236AB)
