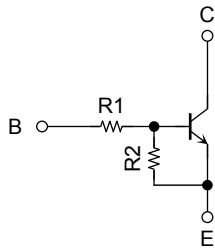

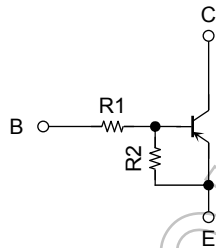
- Two devices are incorporated into an Extreme-Super-Mini (5-pin) package.

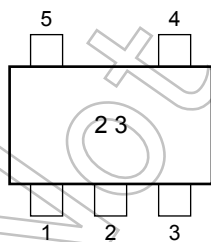

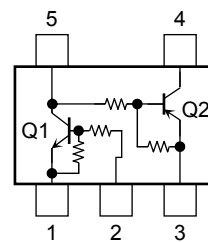

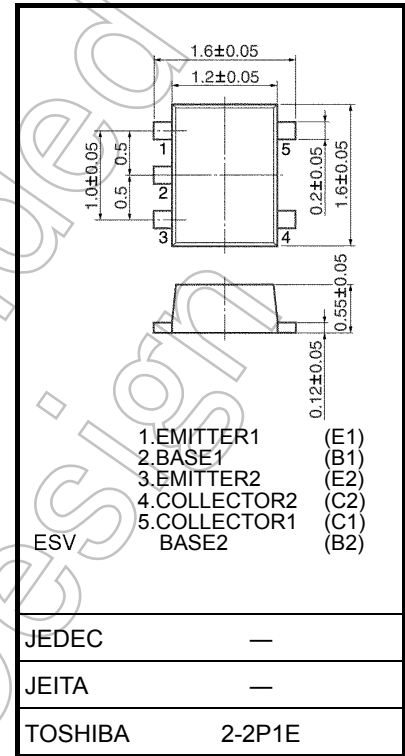
