

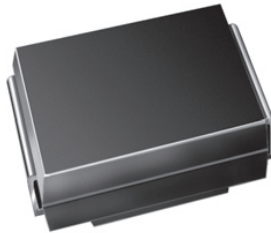

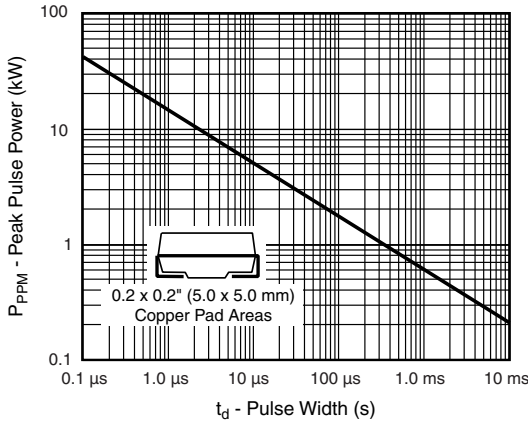


Fig. 1 - Peak Pulse Power Rating Curve
