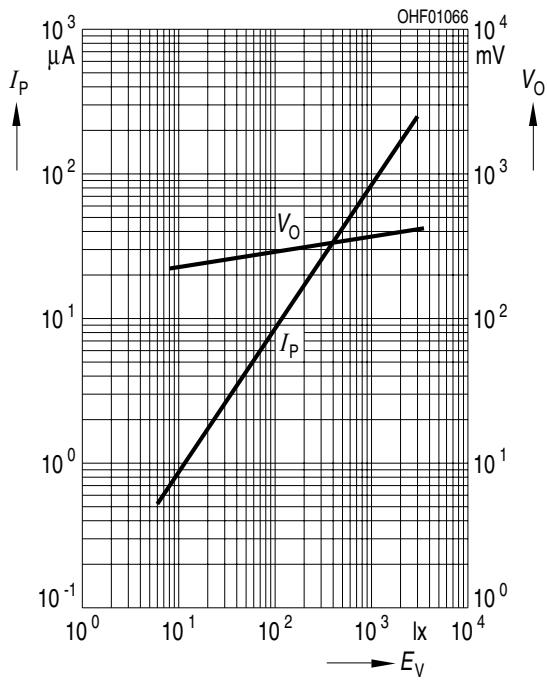

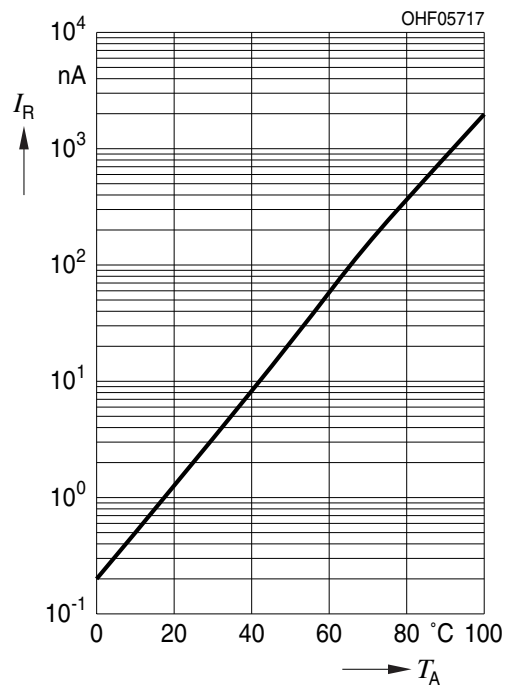

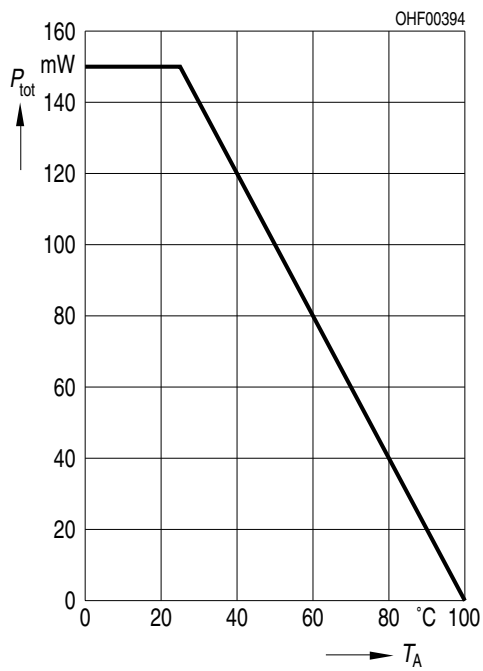

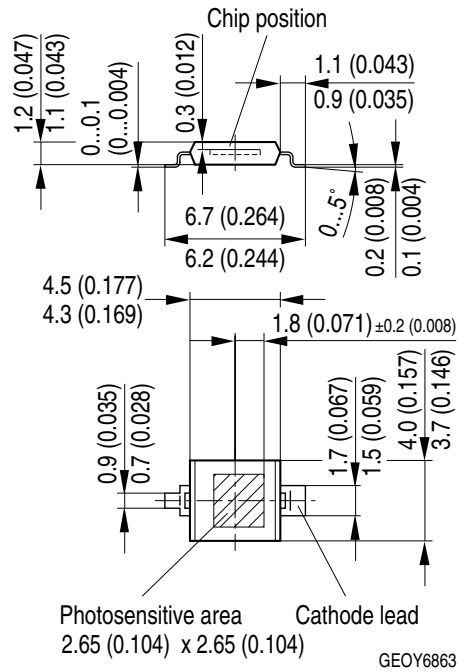


Power Consumption

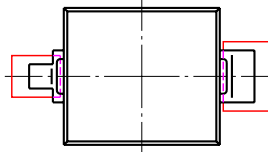

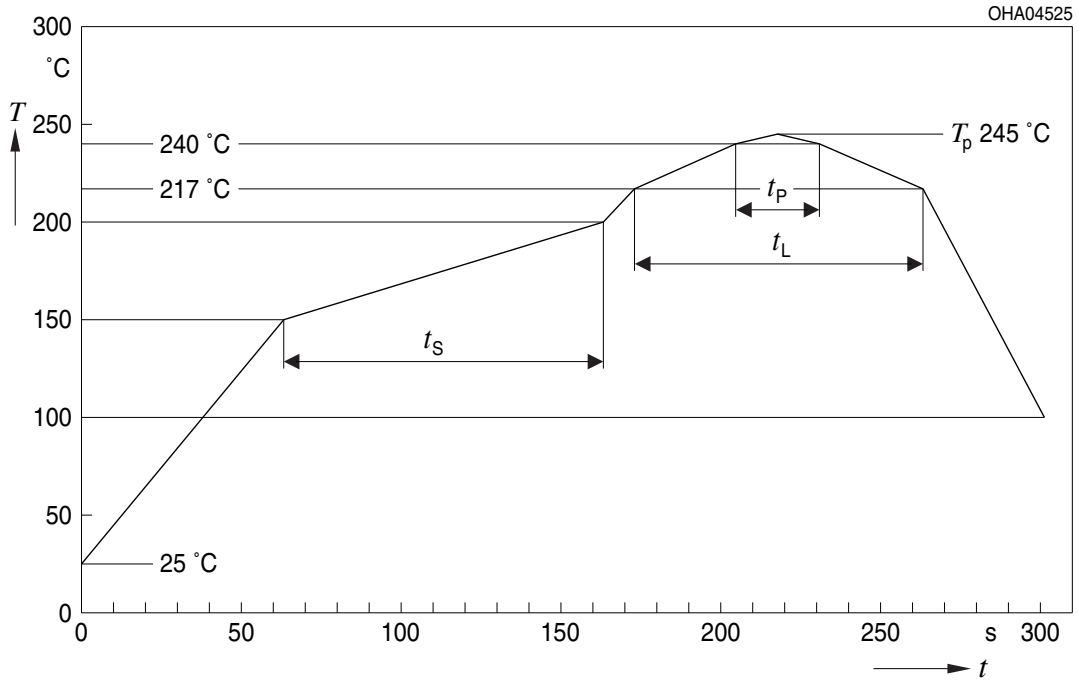
Component Location on Pad

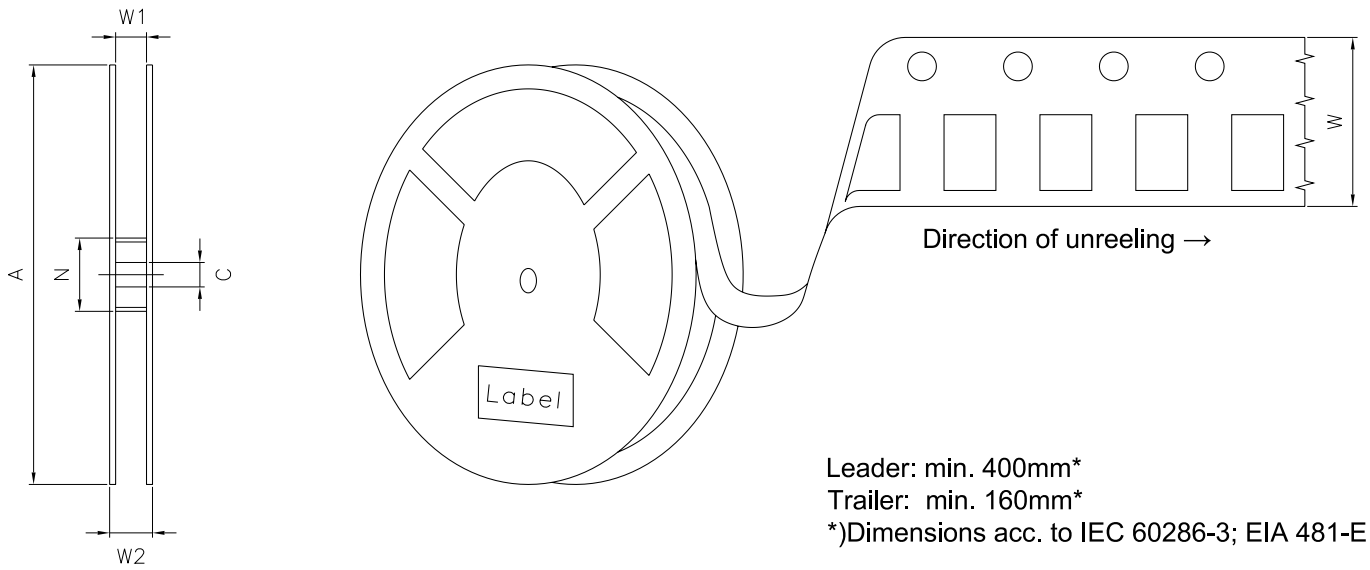

Notes
