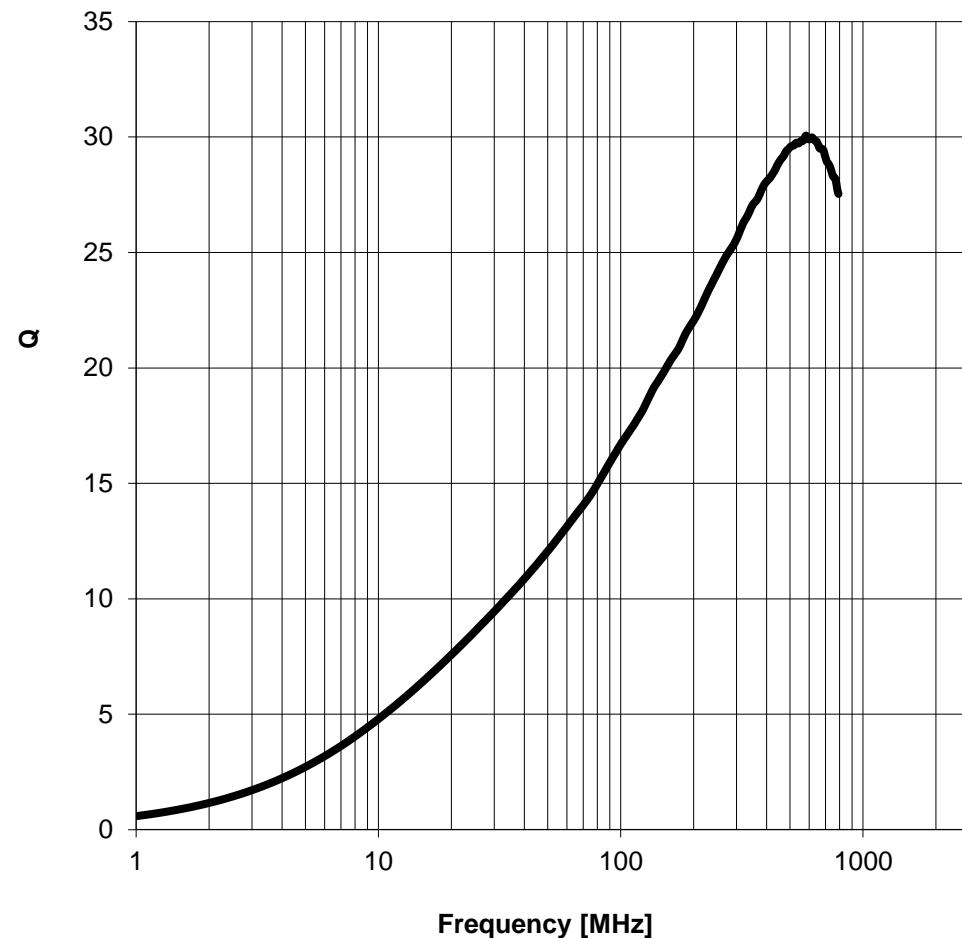

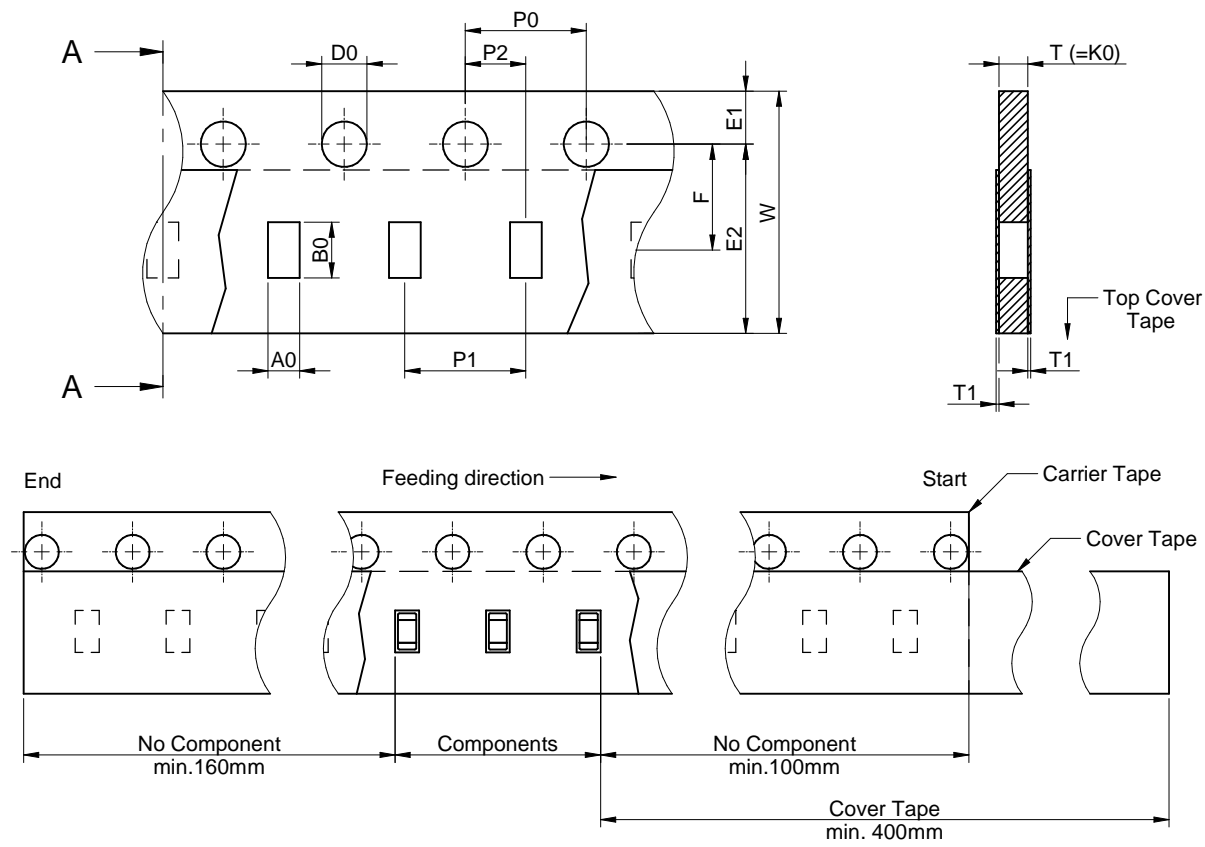

#### Soldering:




