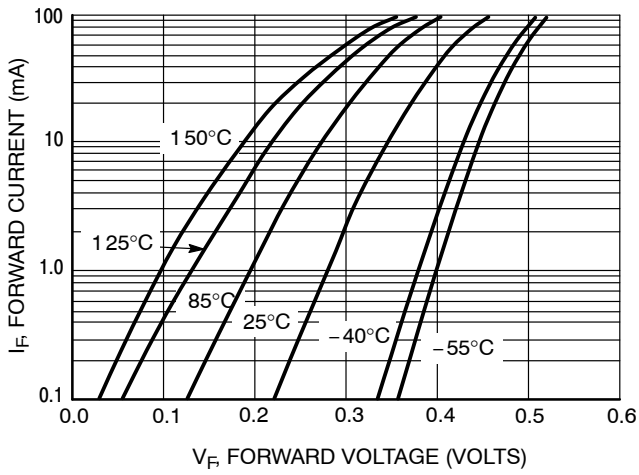

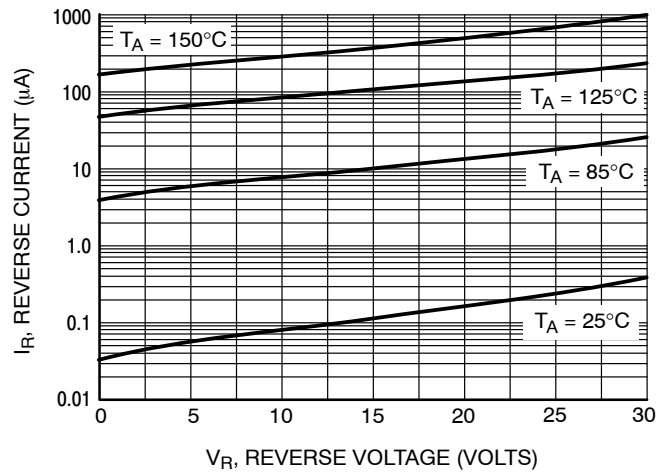

Figure 1. Recovery Time Equivalent Test Circuit

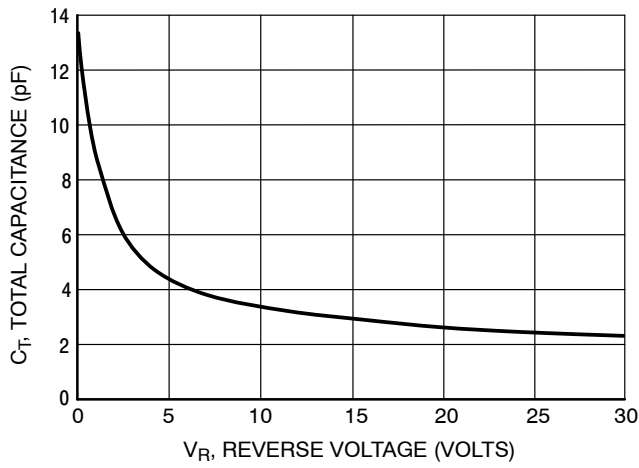

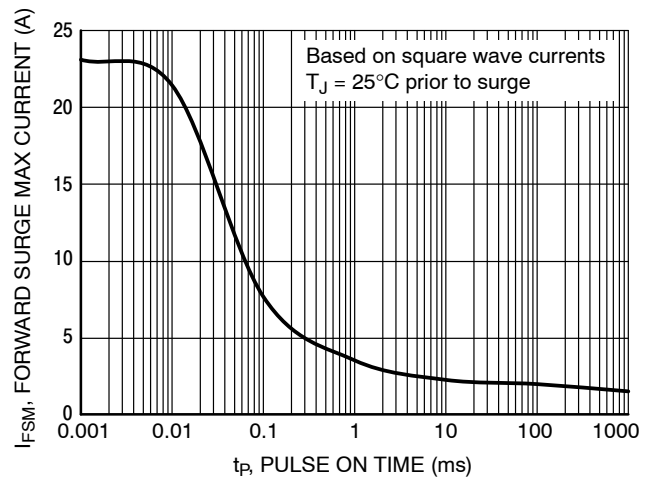
**Figure 2. Forward Voltage**
