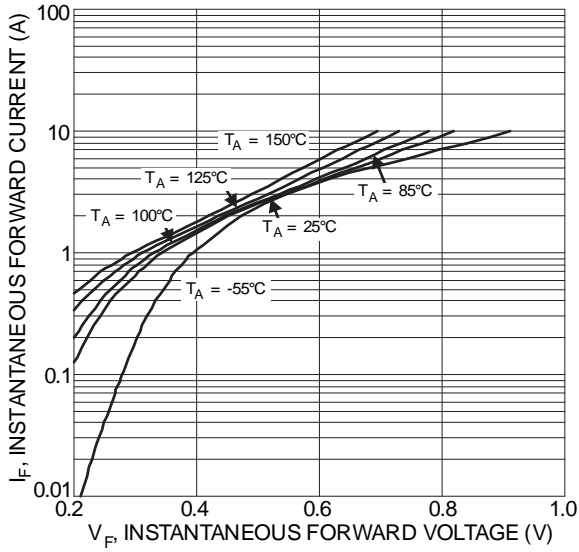


Figure 1 Typical Forward Characteristics

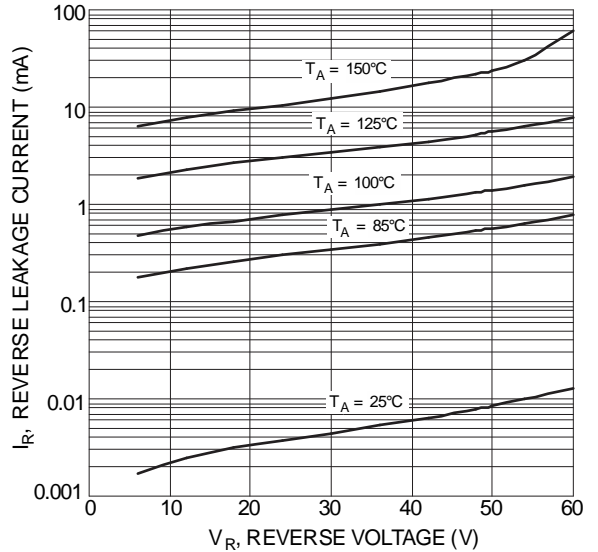


Figure 2 Typical Reverse Characteristics

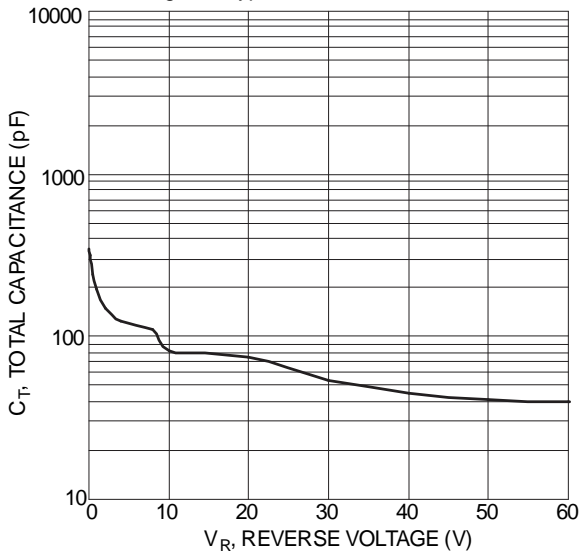


Figure 3 Total Junction Capacitance

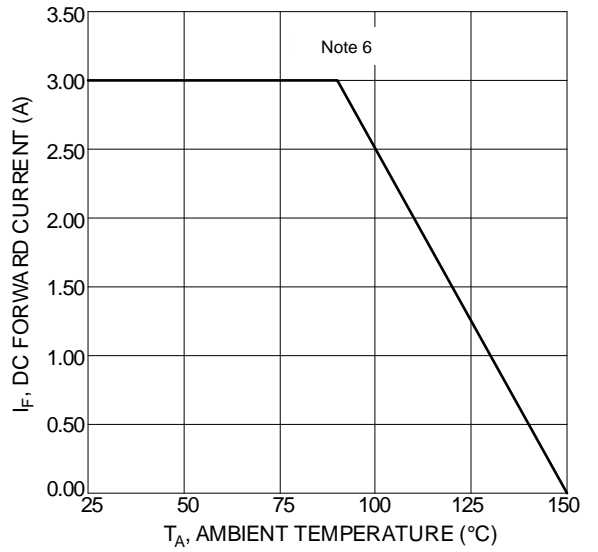
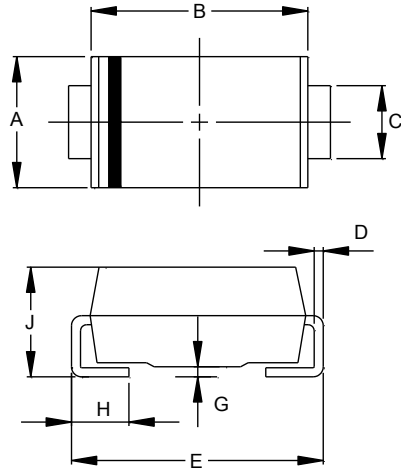


Figure 4 DC Forward Current Derating Curve

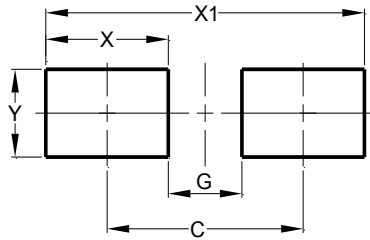
