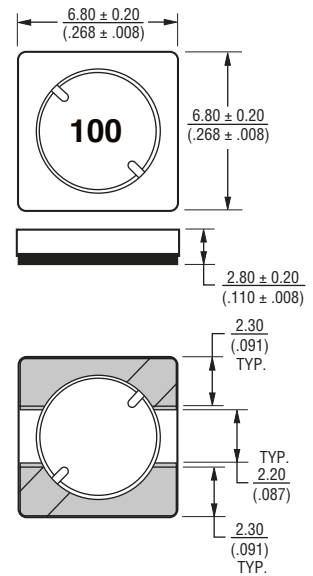

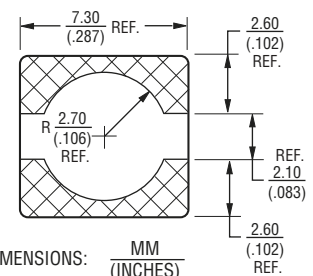

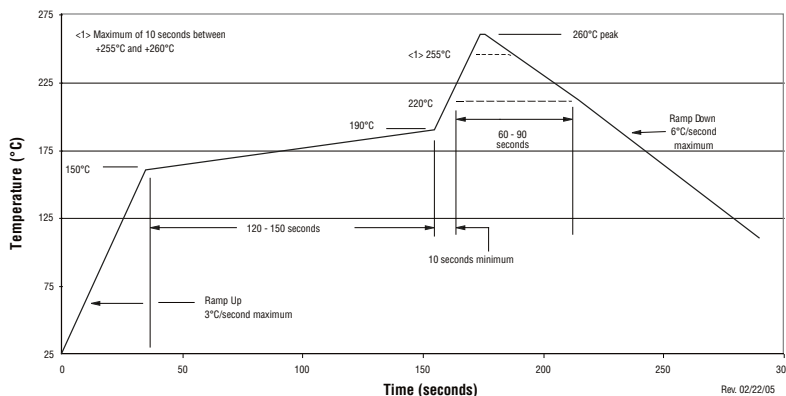


## Recommended Layout

## Soldering Profile



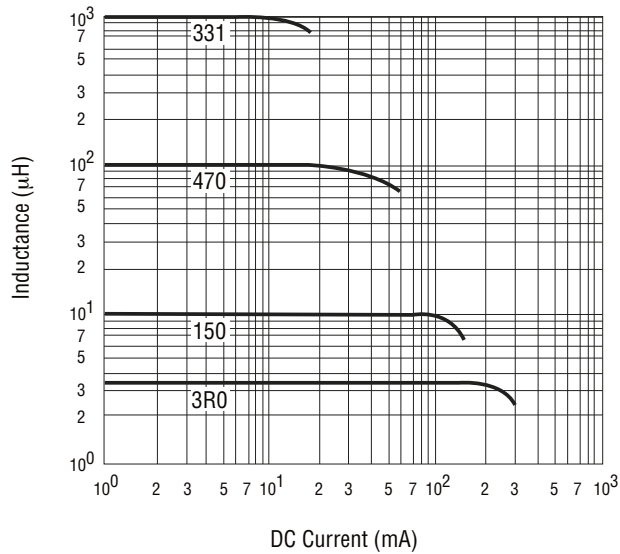

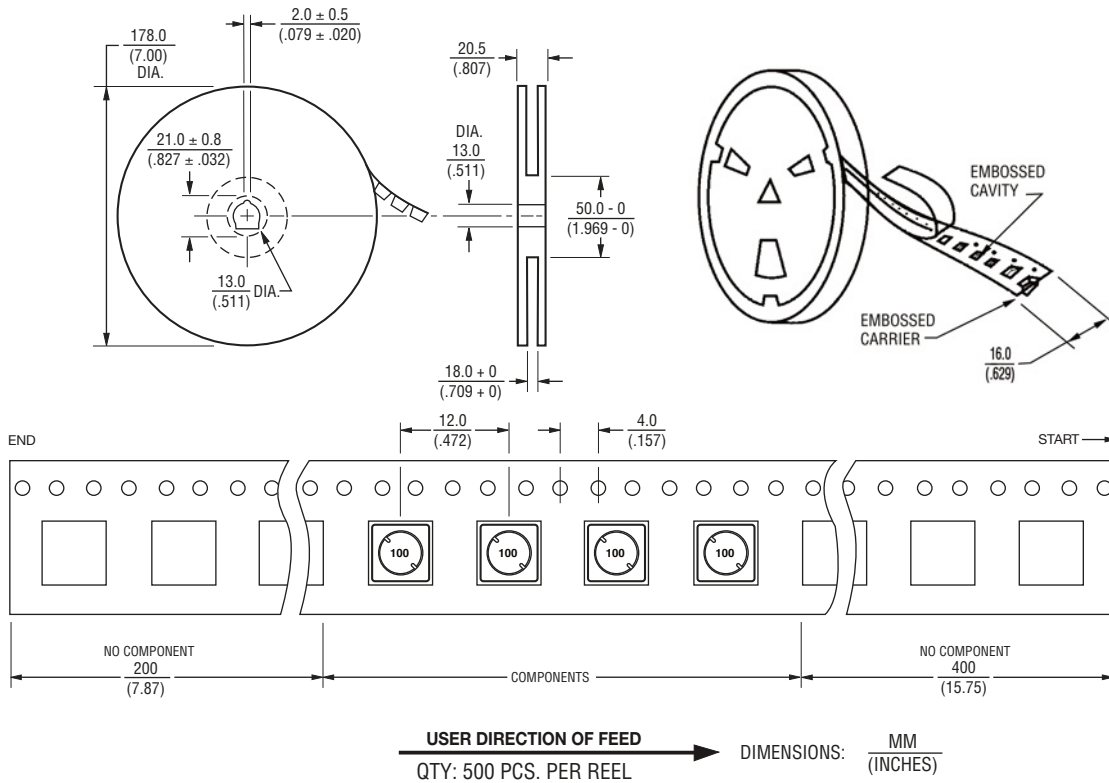
## Inductance vs. Current
