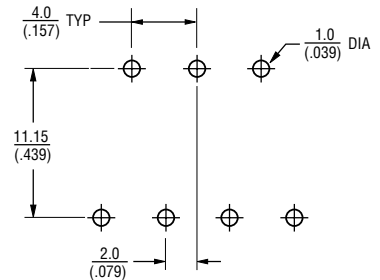
#### RECOMMENDED PWB MOUNTING PATTERN

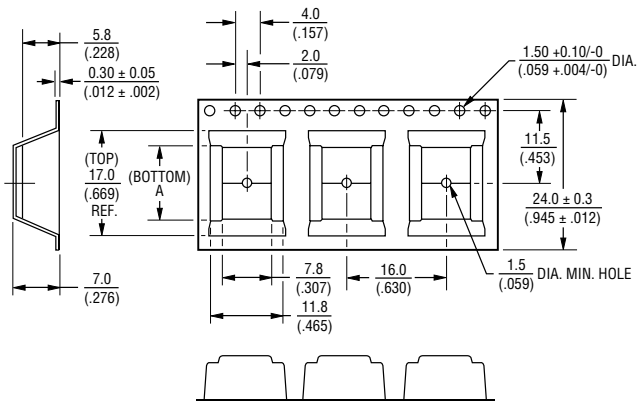

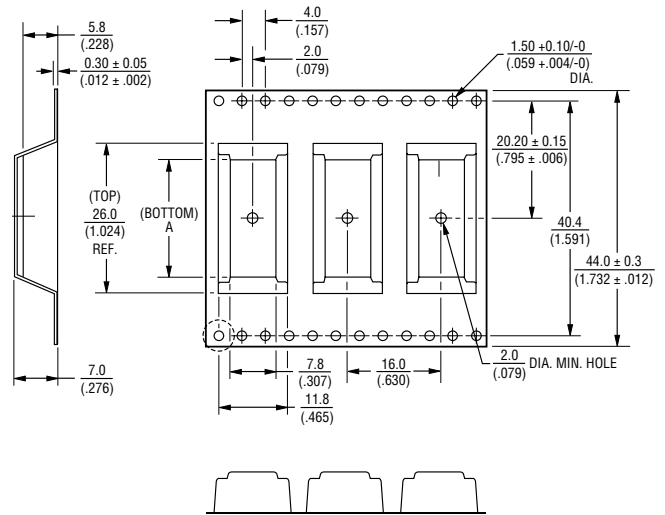

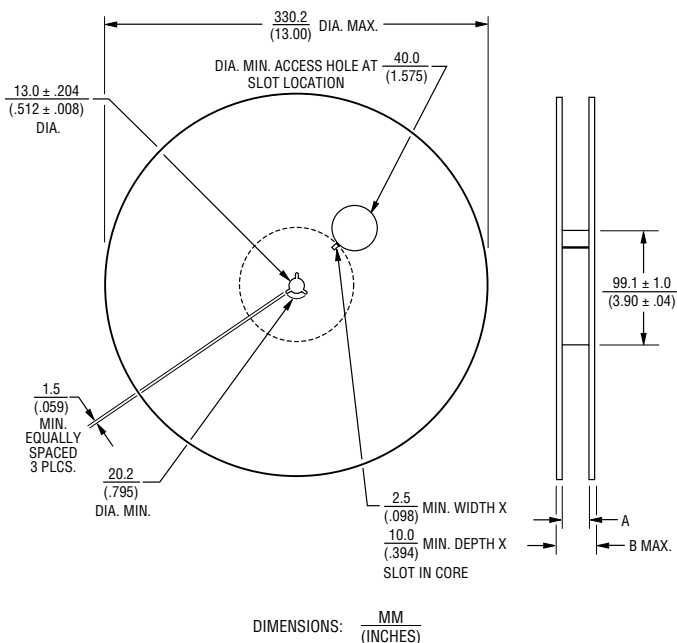
