Typical Inductance vs. Frequency Characteristics:



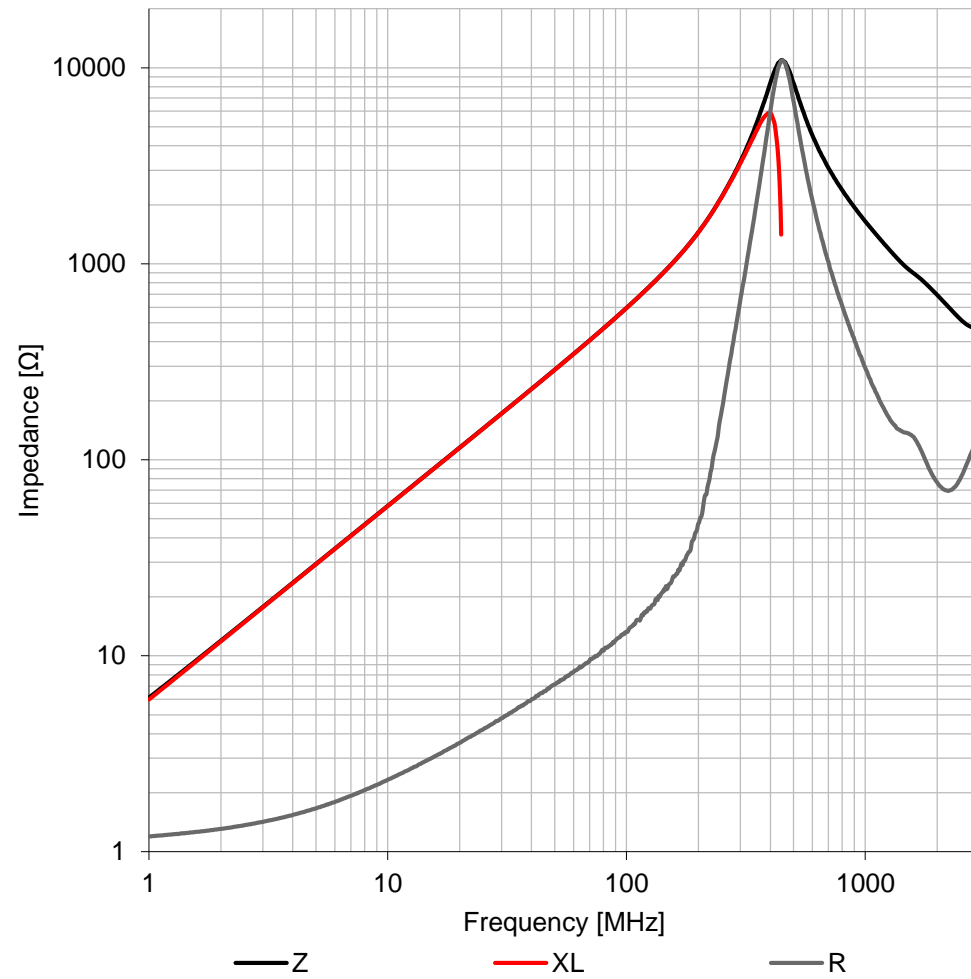

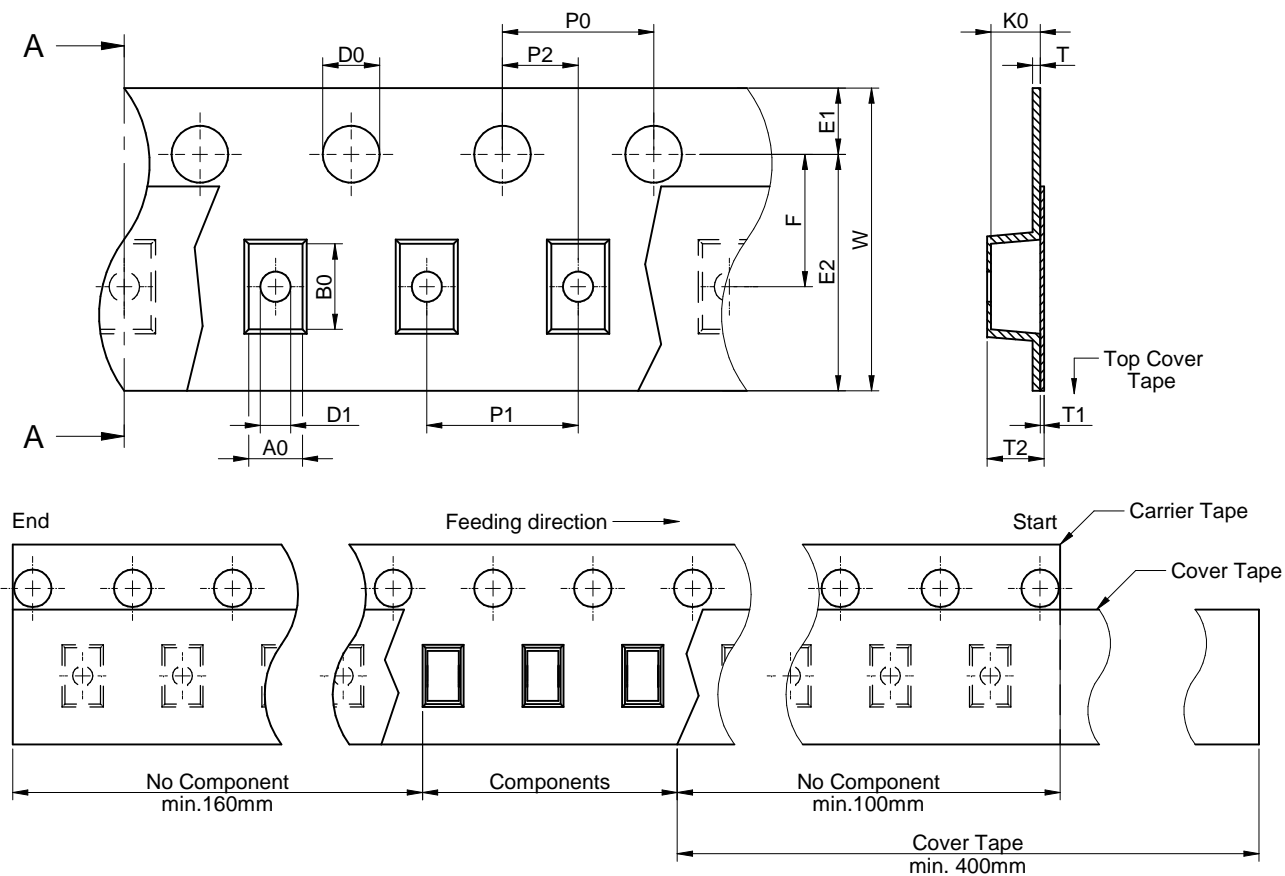
Typical Impedance vs. Frequency:

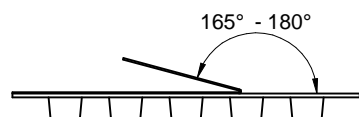

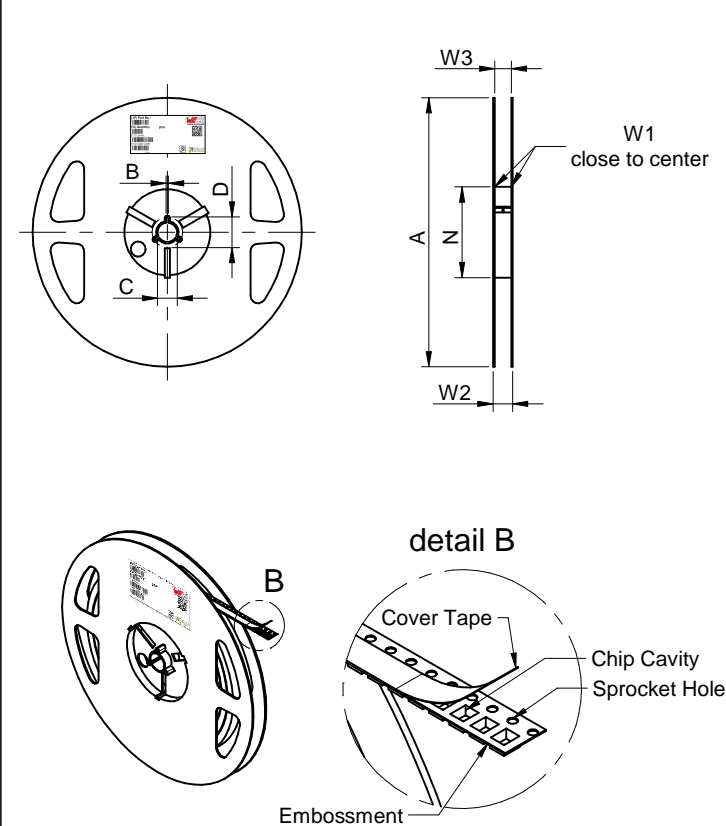

Soldering:




