# 74LVC1G32-Q100

Single 2-input OR gate

## 1. General description

The 74LVC1G32-Q100 is a single 2-input OR gate. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments. Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times. This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.







**Fig. 1. Logic symbol**




**Fig. 2. IEC logic symbol**




**Fig. 3. Logic diagram**

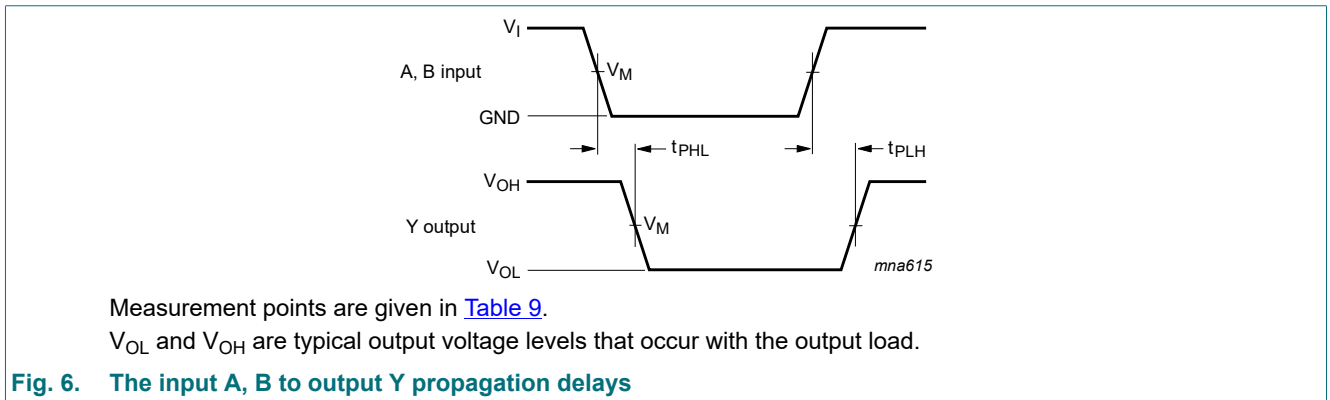

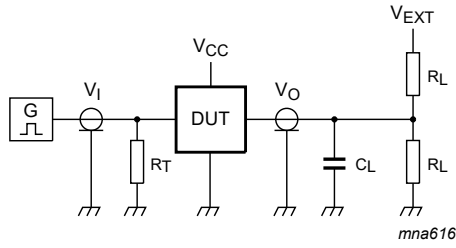

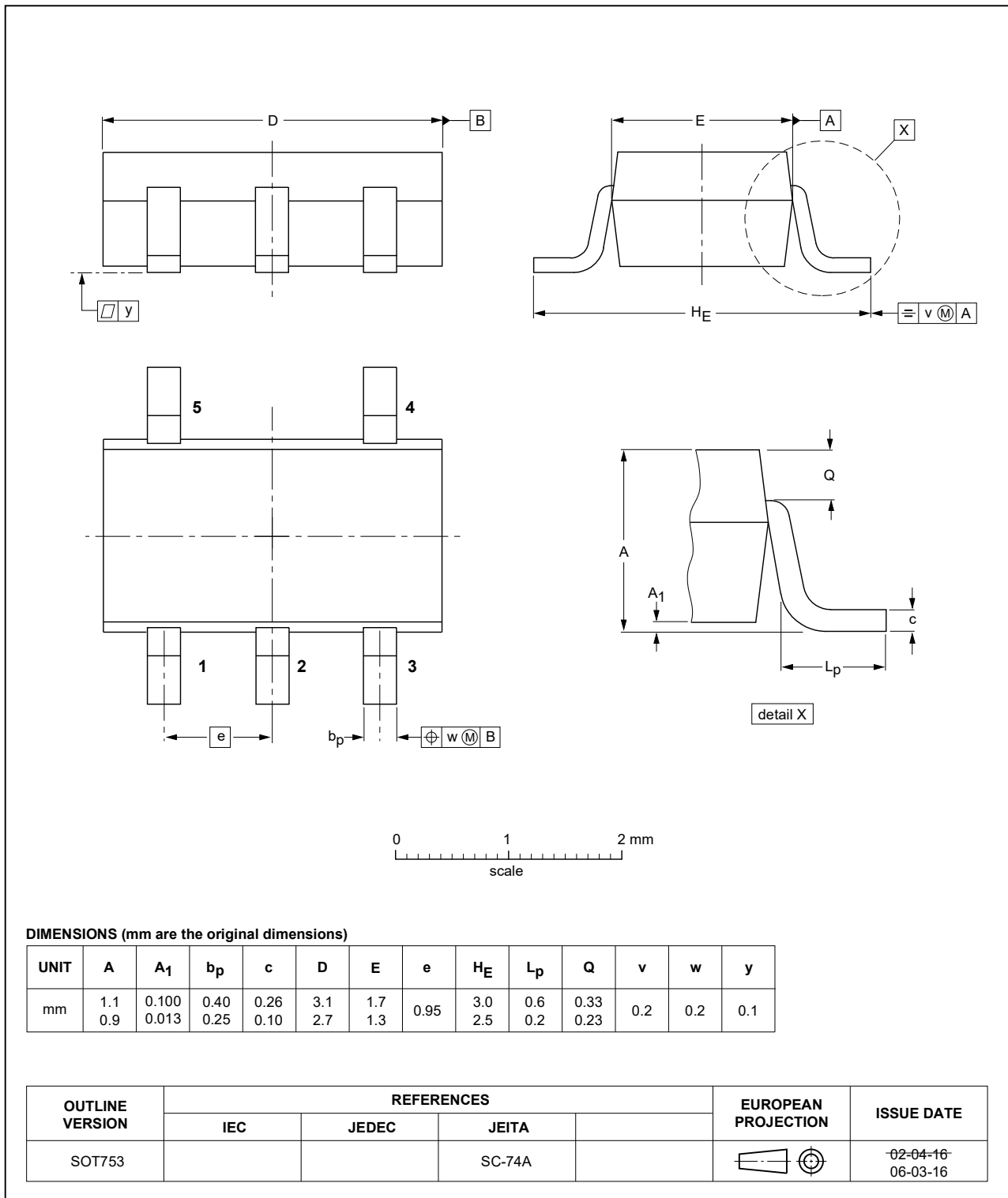


Fig. 9. Package outline SOT753 (SC-74A)

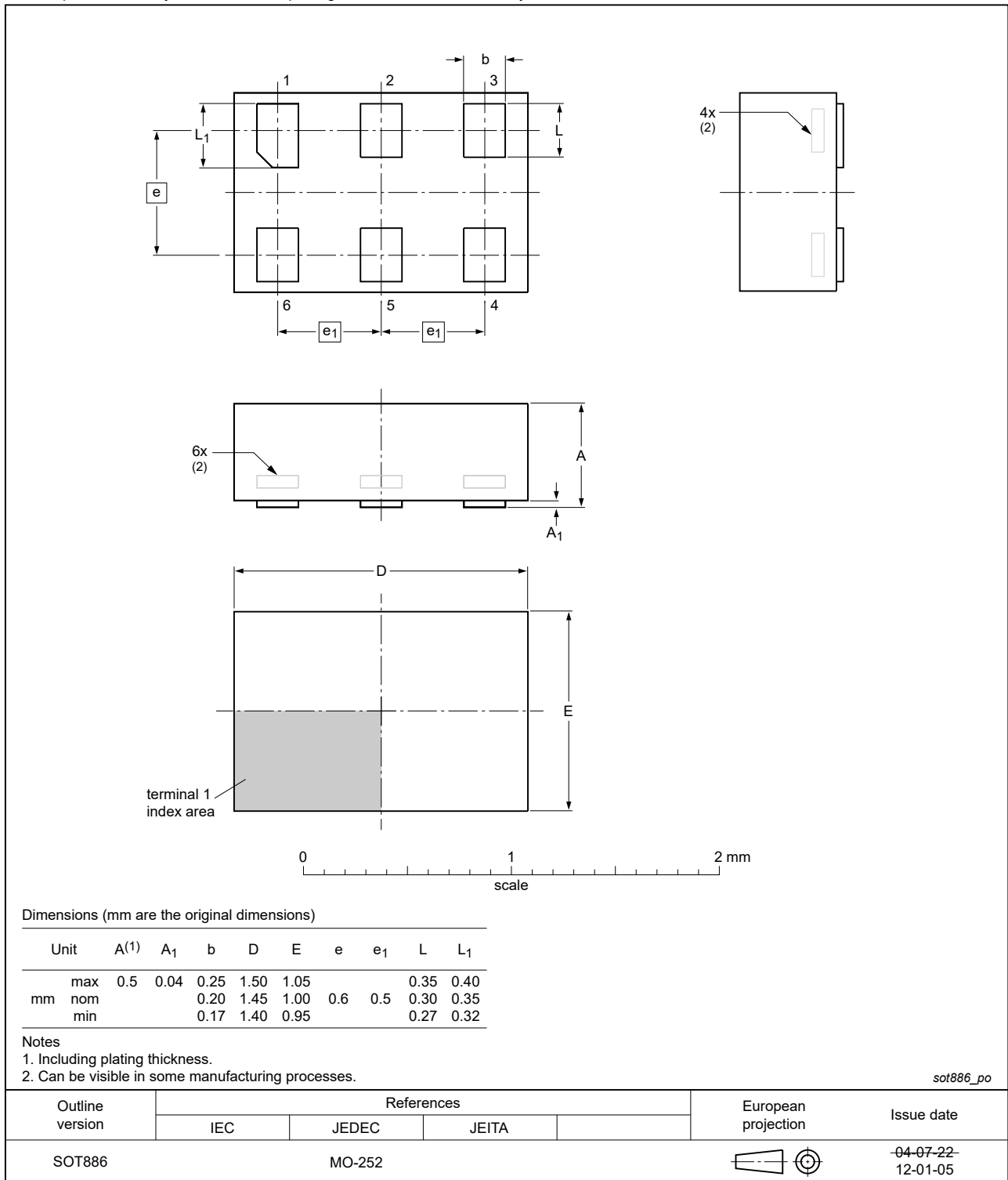


Fig. 10. Package outline SOT886 (XSON6)
